Number 322 - 2006

To amend By-law 270-2004, as amended

The Council of The Corporation of the City of Brampton ENACTS as follows:

1. By-law 270-2004, as amended, is hereby further amended:

(1) by changing Schedule A thereto of the By-law, the zoning designation of the lands shown outlined on Schedule A to this by-law:

FROM	TO
Agricultural (A) and Floodplain (F)	Residential Single Detached C - Section 1819 (R1C-1819), Institutional One Zone - Section 1940 (I1-1940), Open Space (OS) and Floodplain (F)

2. By adding thereto, the following sections:

“1940 Lands designated II-Section 1940 on Schedule A to this by-law:

1940.1 shall only be used for either:


- (1) (a) a public or private school;
- (b) a day nursery;
- (c) a park, playground or recreation facility operated by a public authority; and,
- (d) purposes accessory to the other permitted purposes.

or:


- (2) (a) those purposes permitted in an R1C-1819 zone.”

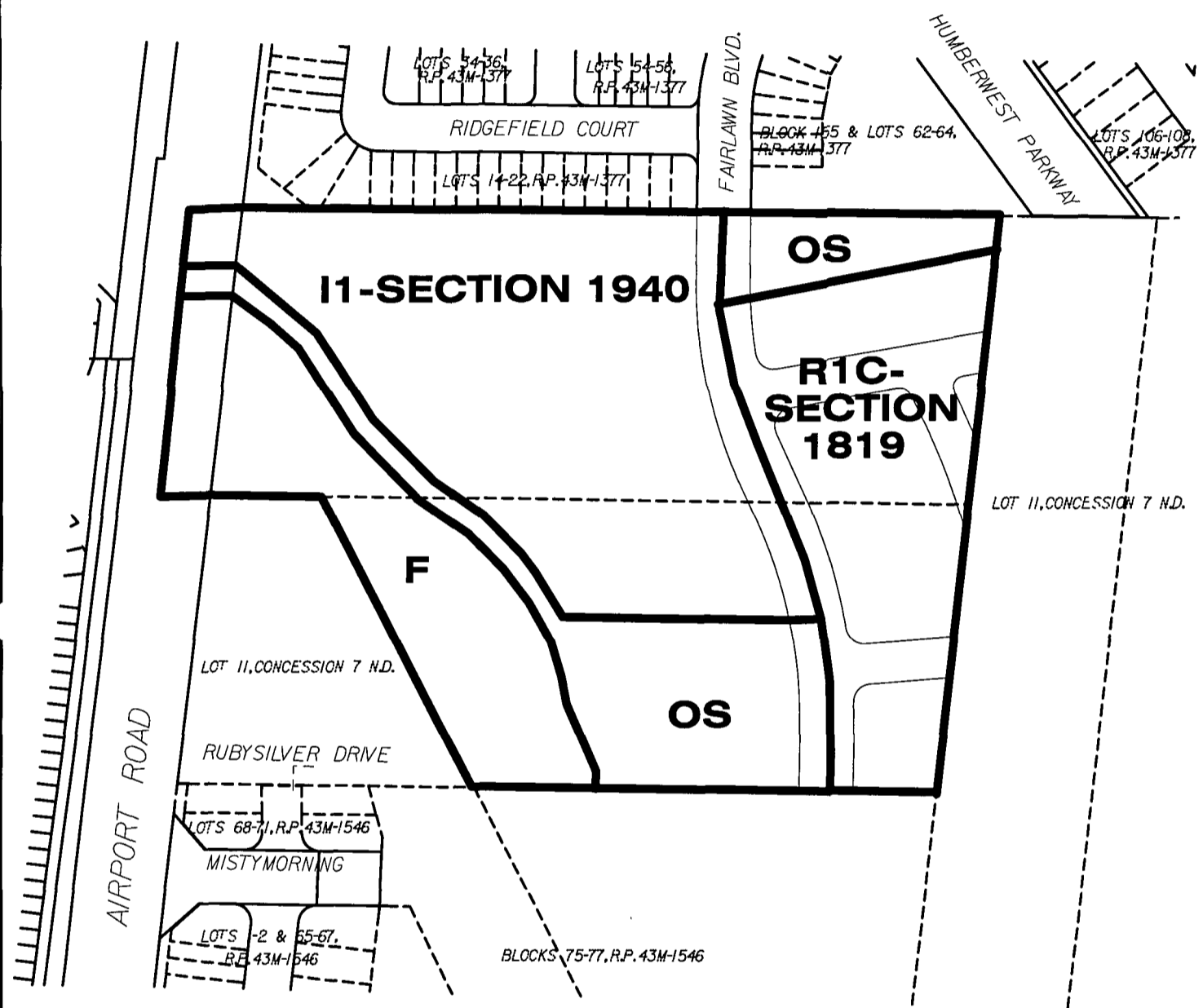

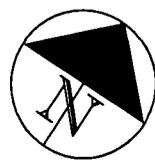
LEGEND

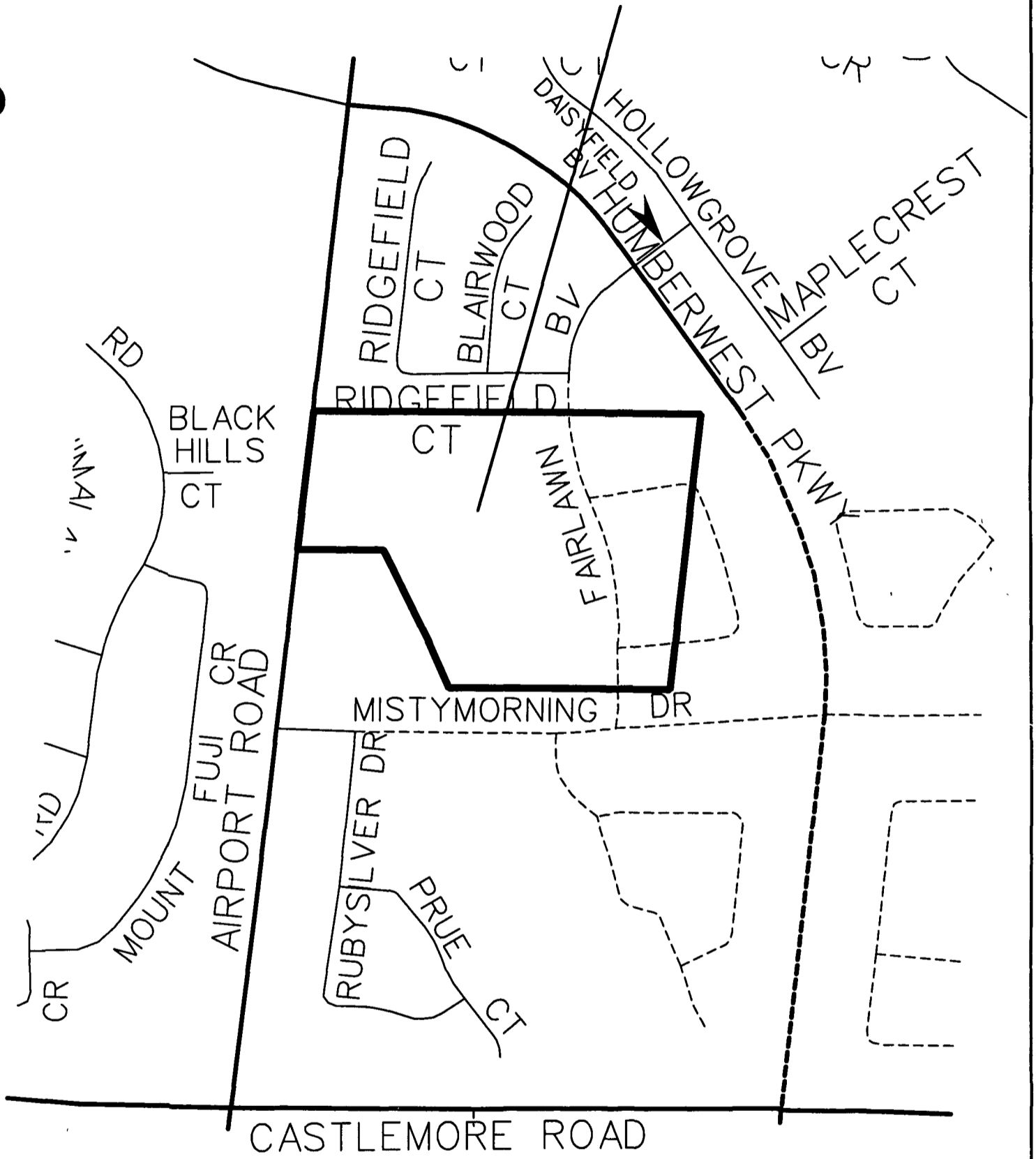
