The Council of the Corporation of the City of Brampton ENACTS AS FOLLOWS:

- 1. Section 4 of By-law 205-79 is hereby repealed and the following substituted therefor:
 - "4. Each private roadway
 - (1) which is located on a property of which the municipal address or location is listed in Schedule A hereto, and
 - (2) beside or near which there are signs marking it as a fire route,

is hereby designated as a fire route. '
