BY-LAW

Number 324-2005

To amend By-Law 275-2004, as amended by By-Law 262-2005, An Interim Control By-Law Applicable to Part of the Area Subject to Zoning By-Law 270-2004.

The Council of the Corporation of the City of Brampton ENACTS as follows:

1. By-Law 275-2004, as amended, is hereby further amended by adding the following:
 - 1.1 Notwithstanding Section 1, the lands described as Part Lot 6, Concession 2, E.H.S., known municipally as 252 Queen Street East, and referenced as the "Lands Subject to Specific Exemption from Interim Control By-Law 275-2004, as amended by By-Law ~~324-2005~~ as outlined on Schedule A to this by-law may permit a grocery store limited to a maximum size of 3,175 square feet (295 square metres) and restricted to Unit 11-12 .
 - 1.2 Schedule A is deleted and replaced with Schedule A attached to this By-Law.

READ a FIRST, SECOND AND THIRD TIME, and PASSED, in OPEN COUNCIL, this 24th day of October 2005.

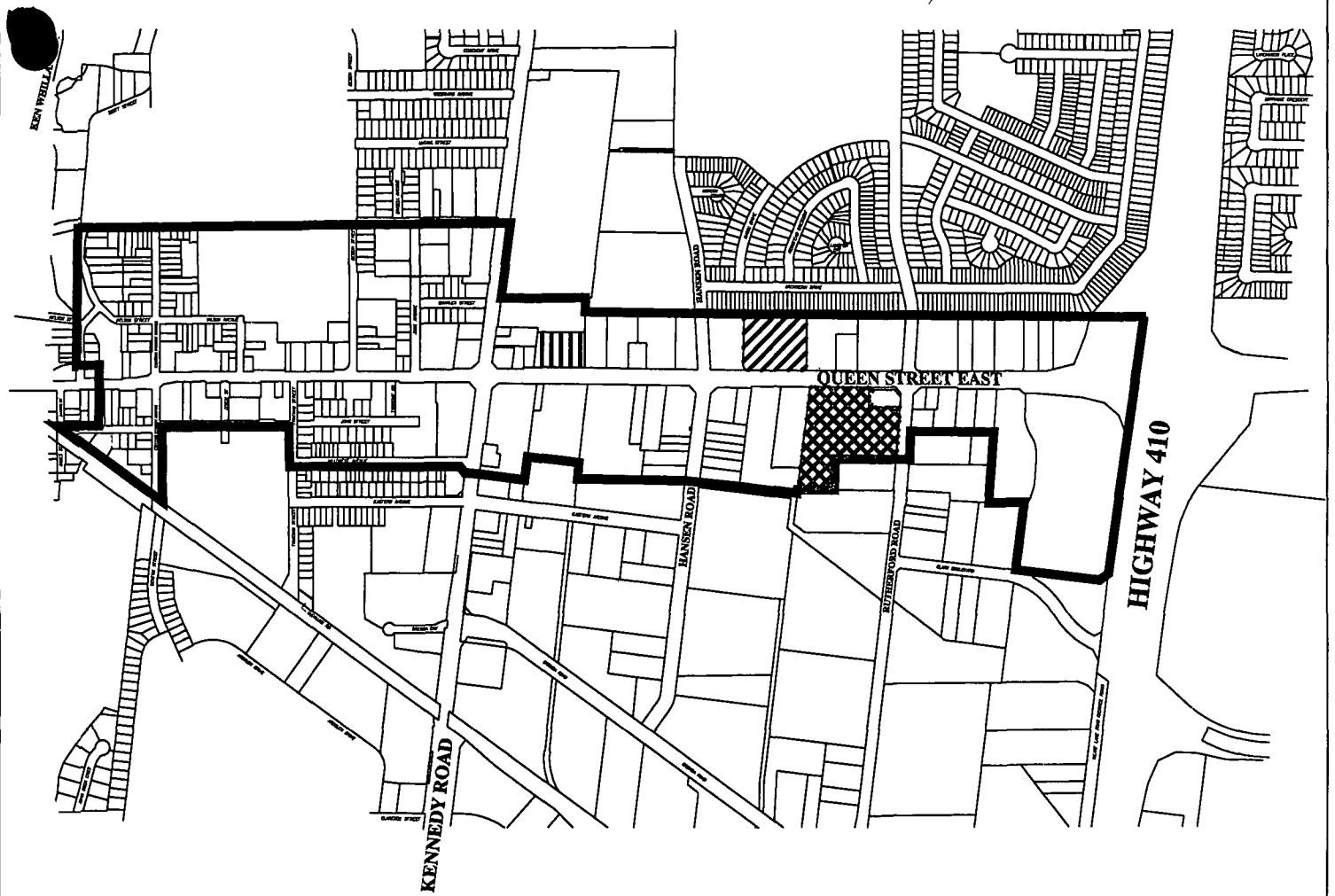

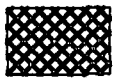

Lands Subject to Specific Exemption from Interim Control By - Law **275 - 2004** as Amended by By-Law **324 - 2005**



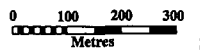
Lands Subject to Specific Exemption from Interim Control By - Law **275 - 2004** as Amended by By-Law **261 - 2005**



Lands Subject to Specific Exemption from Interim Control By - Law **275 - 2004** as Amended by By-Law **355 - 2004**

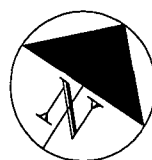


Lands Subject to Interim Control By-Law **275 - 2004** , as Amended



DECLARATION


I, Leonard Joseph Mikulich, of the Town of Shelburne, in the County of Dufferin, do solemnly declare that:
