A By-law to appoint Officers to Enforce Parking on Private Property and to Repeal By-law 311-2009

WHEREAS section 9 of the *Municipal Act, 2001* S.O. 2001, c. M.25, as amended ("*Municipal Act*") gives powers and privileges of a natural person for exercising its authority under the *Municipal Act* or any other Act;

**AND WHEREAS** section 227 of the *Municipal Act* establishes the role of employees to carry out duties required or assigned under the *Municipal Act* or any other Act;

AND WHEREAS section 15 of the *Police Services Act* R.S.O. 1990, c.P.15 authorizes the appointment of Municipal Law Enforcement Officers who shall be peace officers for the purposes of enforcing the by-laws of the Municipality;

**NOW THEREFORE** the Council of The Corporation of the City of Brampton ENACTS as follows:

- 1. The persons named in Column 1 of Schedule A to this By-law are hereby appointed as By-law Enforcement Offices for the purpose of By-law 93-93, as amended, but only in respect of the corresponding properties named and identified in Column 2 of Schedule A to this By-law. Where no municipal address is set out in Column 2 the said officers may enforce By-law 93-93, as amended in respect of all the properties located upon the streets listed in Column 2.
- 2. In enforcing By-law 93-93, as amended, a By-law Enforcement Officer appointed under this By-law may only take the actions authorized by Sections 46, 47, 48 and 55 but not including Section 55(1) of By-law 93-93, as amended.
- By-law 311-2009 is hereby repealed.
- 4. A municipal law enforcement officer appointed by this By-law may enter on the land identified in Column 2 of Schedule A to this By-law at any reasonable time for the purpose of carrying out an inspection to determine whether or not Sections 46, 47, 48 and 55 but not including Section 55(1) of By-law 93-93 of The Corporation of the City of Brampton passed under the *Municipal Act* is being complied with.

A municipal law enforcement officer appointed by this By-law may enter on the land identified in Column 2 of Schedule A to this By-law at any reasonable time for the purpose of carrying out an inspection to determine whether or not Sections 46, 47, 48 and 55 but not including Section 55(1) of By-law 93-93 of The Corporation of the City of Brampton passed under the *Municipal Act* is being complied with.

**CLERK** 

- 5. A municipal law enforcement officer exercising a power of entry may:
  - (a) require production for inspection of documents or things relevant to the inspection;
  - (b) inspect and remove documents or things relevant to the inspection for the purpose of making copies or extracts;
  - (c) require information from any person concerning a matter related to the inspection; and
  - (d) alone or in conjunction with a person possessing special or expert knowledge, make examinations or take tests, samples or photographs necessary for the purposes of the inspection.
- 6. Subject to section 7, this By-law prevails to the extent of any conflict between this By-law and any other by-law of The Corporation of the City of Brampton.
- 7. This By-law does not restrict any rights conferred by the *Municipal Act* or any other Act or regulation, respecting entry to land.
