BY-LAW

Number 324-2010

To amend Traffic By-law 93-93 by amending the Schedules relating to PROHIBITED TURNS (Schedule VII), FIRE ROUTES (Schedule XXII), DESIGNATED TURNING LANES (Schedule VI), NO STOPPING (Schedule XV), NO PARKING (Schedule XIV) and AUTHORIZED RESIDENTIAL PARKING ZONES (Schedule XXXIV)

The Council of the Corporation of the City of Brampton ENACTS as follows:

1. By-law 93-93 as amended, is hereby further amended as follows:

(1) by adding to Schedule VII thereto the following item:

PROHIBITED TURNS


