# **BY-LAW**

To amend By-law 93-93,

#### THROUGH HIGHWAYS, STOP SIGNS, RATE OF SPEED

The council of the Corporation of the City of Brampton hereby  $\operatorname{ENACTS}$  as follows:

- 1. By-law 93-93, as amended, is hereby further amended as follows:
  - (1) by deleting from Schedule III thereto the following items:
