Number 330-2003

To Change the Name of
Blacksmith Crescent

WHEREAS the Council of the Corporation of the City of Brampton deems it necessary to change the name of Blacksmith Crescent;

AND WHEREAS notice of the intention to pass this by-law has been published on October 22, 2003 in The Brampton Guardian, a newspaper having general circulation in the City of Brampton;

AND WHEREAS Council has heard all persons who claimed that they would be adversely affected by this by-law and who applied to be heard;

NOW THEREFORE the Council of The Corporation of the City of Brampton ENACTS AS FOLLOWS:

1. The name of Blacksmith Crescent on registered Plans 43M-1373 and 43M-1459 is hereby changed as follows:
 - (i) Blacksmith Crescent on Plan 43M-1373 to be changed to Winners Circle;
 - (ii) The part of Blacksmith Crescent on Plan 43M-1459 abutting Lot 13 and Blocks 14, 15, 18, 19 and 20 on Plan 43M-1459 to be changed to Winners Circle; and,
 - (iii) The part of Blacksmith Crescent on Plan 43M-1459 abutting Lots 1-9 on Plan 43M-1459 to be changed to Cedarvalley Boulevard.
2. The affidavit of Leonard J. Mikulich attached as Schedule "A" hereto shall form part of this by-law.




1. A public notice respecting the street name change of Blacksmith Crescent was advertised in the Brampton Guardian on October 22, 2003.
