BY-LAW

Number 331-79

To Amend By-law 861, as amended
by By-law 195-75
(Part Lot 4, Concession 3, E.H.S.)

The Council of the Corporation of the City of Brampton ENACTS
as follows:-

1. By-law 861, as amended, and as specifically amended by
By-law 195-75, is hereby further amended:

(1) by adding to By-law 195-75 as Schedule B
thereto the Location Map attached hereto as Schedule A.

(2) by deleting therefrom section 4.1, as set out
in By-law 195-75, and substituting therefor
the following:

"4.1 The lands shown outlined on Schedule
A hereto shall only be used for the
following purposes:

- (1) dwellings
- (2) apartments
- (3) school
- (4) religious institution
- (5) public library
- (6) a store retailing groceries,
stationary, and other goods of
the kind usually found in what
are known as "convenience stores".

(3) by adding thereto, as section 4.5, the following
section:


"4.5 (a) The store shall be located within
the area designated for it on the
Location Map attached hereto as
Schedule B;

- (b) No storage of goods shall be permitted outside the building.
- (c) No signs or posters other than one indicating the name of the store and of the dimensions not exceeding 30 cms. by 1 metre shall be permitted outside the building."

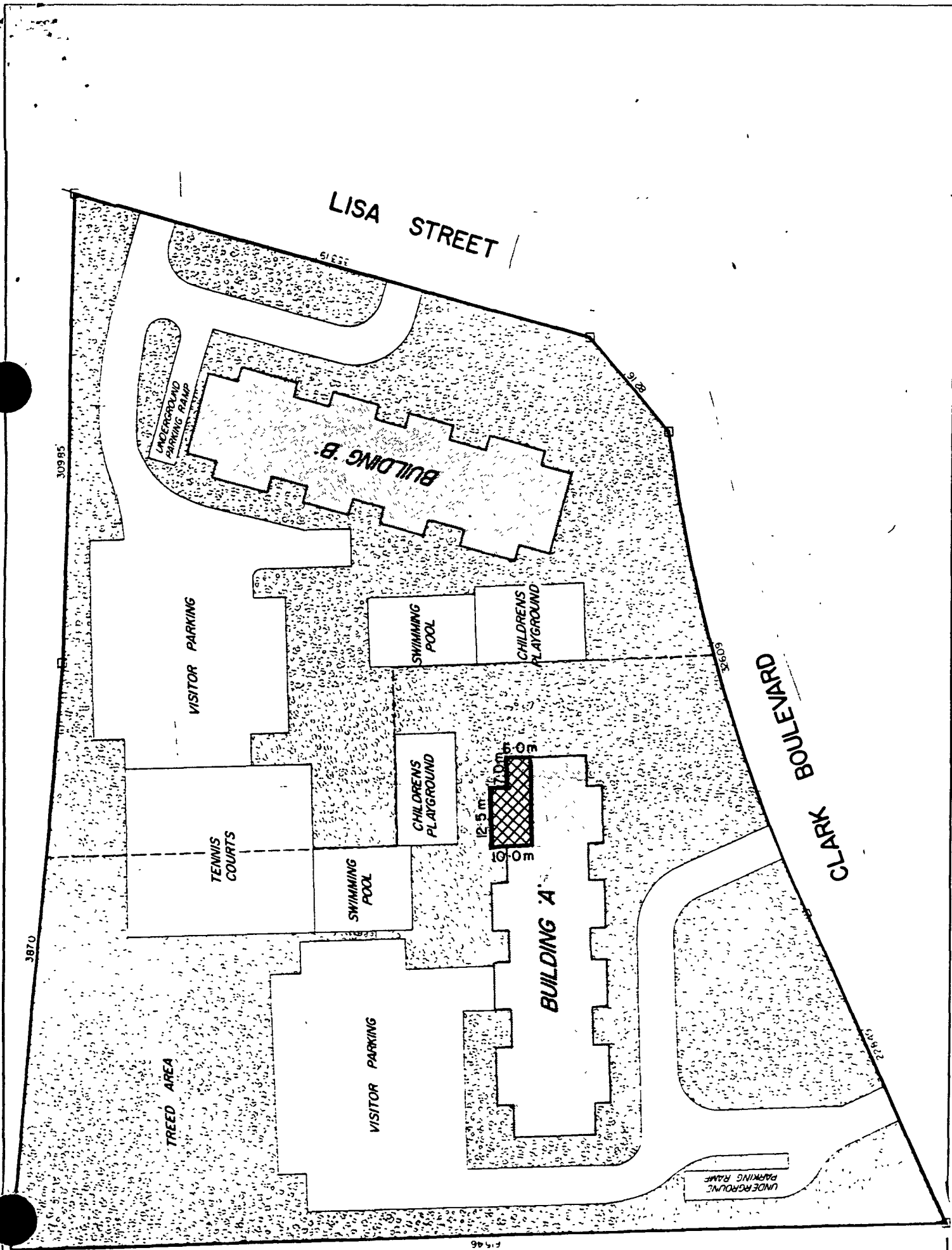
