BY-LAW

Number 339285

To stop up and close and
authorize the sale of certain
Streets on Registered Plan M-112

WHEREAS it is deemed expedient in the interest of The Corporation of the City of Brampton that certain streets on Registered Plan M-112 be stopped up and closed, and sold to the owners of the abutting lands;

AND WHEREAS notice of the intention to pass this By-law has been published once a week for four consecutive weeks in the Daily Times, a newspaper having general circulation in the City of Brampton.

AND WHEREAS the said Corporation has given notice to The Regional Municipality of Peel, pursuant to section 49 of the Regional Municipality of Peel Act (R.S.O. 1980, c. 440, as amended) and The Regional Municipality of Peel has indicated that it does not object to such stopping up;

AND WHEREAS the Council for the Corporation has heard in person or by his counsel, solicitor or agent, all persons claiming that their land will be prejudicially affected by this By-law and who applied to be heard;

NOW THEREFORE the Council of The Corporation of the City of Brampton ENACTS AS FOLLOWS:

1. The streets on Registered Plan M-112 more particularly described in Schedule A attached to this By-law be and the same are hereby stopped up and closed.
2. The sale of the lands stopped up and closed by this By-law, to First City Development Corp. Ltd., for the sum of \$2.00, is hereby authorized.
3. The Mayor and Clerk are hereby authorized to execute all documents and instruments as may be necessary to effect the conveyance of the lands stopped up and closed by this By-law.

READ a FIRST, SECOND and THIRD TIME and PASSED in Open Council this 18th day of November, 1985.



SCHEDULE A TO BY-LAW 339-85

The land situated in the City of Brampton, in the Regional Municipality of Peel, and being composed of:

- FIRSTLY: The whole of Pinellas Drive according to a plan of subdivision registered in the Land Registry Office for the Land Titles Division of Peel (No. 43) as number M-112.
- SECONDLY: The whole of Killarney Square according to said registered plan M-112.
- THIRDLY: Mount Pleasant Drive according to registered plan M-112, save and except the part of Mount Pleasant Drive shown as Part 1 on a reference plan deposited in said Land Registry Office as number 43R-12900.
