BY-LAW

Number 35-2004

To amend By-law 93-93,

DESIGNATED TURNING LANES, SCHOOL BUS LOADING ZONES, RATE OF SPEED, FIRE ROUTES

The council of the Corporation of the City of Brampton hereby ENACTS as follows:

1. By-law 93-93, as amended, is hereby further amended as follows:

(1) by adding to Schedule VI thereto the following items:

DESIGNATED TURNING LANES

COLUMN 1 HIGHWAY	COLUMN 2 BETWEEN	COLUMN 3 LANE	COLUMN 4 DIRECTION	COLUMN 5 COMPULSORY TURN
Ray Lawson Boulevard	A point 71 metres west of Hurontario Street and Hurontario Street	Curb Lane	Eastbound	Right Turn

(2) by deleting from Schedule VIII thereto the following items:

SCHOOL BUS LOADING ZONES

Mary Street	West	a point 270 metres south of Armstrong Street to a point 65 metres south thereof	Cardinal Leger Secondary School

(3) by adding to Schedule VIII thereto the following items:

SCHOOL BUS LOADING ZONES

COLUMN 1 HIGHWAY	COLUMN 2 SIDE	COLUMN 3 BETWEEN	COLUMN 4 SCHOOL OR INSITUTION
Guest Street	North	A point 10 metres east of Beatty Avenue and a point 65 metres east thereof	Cardinal Leger Secondary School

- (4) by adding to Schedule X thereto the following items:

RATE OF SPEED

COLUMN 1 HIGHWAY	COLUMN 2 RATE OF SPEED	COLUMN 3 BETWEEN	COLUMN 4 TIMES OR DAYS
Gallucci Crescent	40	Don Minaker Drive (westerly intersection) and a point 340 metres south/east of Don Minaker Drive (westerly intersection)	Anytime

- (5) by adding to Schedule XV thereto the following items:

NO STOPPING

McCleave Crescent	West	The north limit of the roadway and a point 230 metres east/north of Drinkwater Road	8:00 a.m. to 9:00 a.m. 3:00 p.m. to 4:00 p.m. Monday to Friday




