BY-LAW

Number 311-2010

To amend Traffic By-law 93-93
by amending the Schedules relating to THROUGH HIGHWAYS (Schedule III),
RATE OF SPEED (Schedule X), PROHIBITED TURNS (Schedule VII), FIRE
ROUTES (Schedule XXII) and DESIGNATED TURNING LANES (Schedule VI)

The Council of the Corporation of the City of Brampton ENACTS as follows:

1. By-law 93-93 as amended, is hereby further amended as follows:
 - (1) by removing from Schedule III thereto the following items:




