## **BY-LAW**

Number 386-2002

To appoint Public Health Inspectors for the purpose of enforcing City of Brampton's Smoke Free By-law and to Repeal By-law 243-2002

WHEREAS paragraph 5 of section 213 of the <u>Municipal Act</u> (R.S.O. 1990, c. M.45, as amended) authorizes a local municipality to appoint inspectors for the purposes of enforcing the smoking by-law;

AND WHEREAS section 15 of the <u>Police Services Act</u> (R.S.O. 1990, c. P.15, as amended) authorizes the appointment of Municipal Law Enforcement Officers who shall be peace officers for the purposes of enforcing the by-laws of the Municipality;

NOW THEREFORE the Council of The Corporation of the City of Brampton ENACTS as follows:

1. The following public health inspectors are hereby appointed as Municipal Law Enforcement Officers for the purposes of the enforcement of By-law 115-99 being the Smoking By-law for the City of Brampton:
