To appoint Public Health Inspectors for the purpose of enforcing City of Brampton's Smoke Free By-law and to Repeal By-law 243-2002

WHEREAS paragraph 5 of section 213 of the Municipal Act (R.S.O. 1990, c. M.45, as amended) authorizes a local municipality to appoint inspectors for the purposes of enforcing the smoking by-law;

AND WHEREAS section 15 of the Police Services Act (R.S.O. 1990, c. P.15, as amended) authorizes the appointment of Municipal Law Enforcement Officers who shall be peace officers for the purposes of enforcing the by-laws of the Municipality;

NOW THEREFORE the Council of The Corporation of the City of Brampton ENACTS as follows:




