# AMENDMENT NUMBER OP93-243 TO THE OFFICIAL PLAN OF THE CITY OF BRAMPTON PLANNING AREA

### 1.0 Purpose:

The purpose of this amendment is:

❖ To amend the Gore Industrial North Secondary Plan Area (Secondary Plan Area #14) Land Use Schedule to delete a section of collector road known as the north-south extension of Spar Drive.

#### 2.0 Location:


The lands subject to this amendment are located on the east side of Airport Road south of Williams Parkway. The lands have extensive frontage on Airport Road with additional frontage on both Spar Drive and Ward Road. The lands represent approximately 20.95 hectares (51.769 acres) and are described as the West Half of Lot 7, Concession 7, N.D. (T.G.) (Part 2, Plan 43R-21695) in the City of Brampton.

#### 3.0 Amendments and Policies Relative Thereto:

The document known as the Gore Industrial North Secondary Plan Area (Secondary Plan Area #14) of the City of Brampton Planning Area is hereby amended:

(1) by deleting the section of collector road known as the north-south extension of Spar Drive as shown on Schedule "A" to this amendment;
