

## Notice of Intent to Amend Various City By-laws

- 1. Procedure By-law 160-2004**
- 2. Adult Entertainment Establishment By-law 114-2017**

City Council will consider these matters at its meeting on Wednesday, December 13, 2017, starting at 9:30 a.m.

The City of Brampton intends to amend the following by-laws, for various purposes, as set out below:

### **Procedure By-law 160-2004:**

Recommendations will be considered by Council to amend its Procedure By-law to implement new requirements under the *Municipal Act, 2001*, to be effective January 1, 2018, regarding the following matters:

- New Definition of a “Meeting”;
- Clarity on authority of Member acting in the absence of the Head of Council;
- Implementation of Closed Meeting Investigation Reports; and
- Alternate Council Member for absence of Member at Regional Council.

### **Adult Entertainment Establishment By-law 114-2007:**

Recommendations will be considered by Council to amend the Adult Entertainment Establishment By-law to make housekeeping amendments to recognize three (3) pre-existing Adult Merchandise Stores that do not meet the 500 metre separation requirement from residential areas, as required in the by-law. The three business locations include:

- Two (2) pre-existing store locations (2200 Queen Street East and 267 Queen Street East) that have been operational and continually licensed under the City’s previous Licensing By-law 1-2002.
- One (1) pre-existing store location (158 Kennedy Road South) that did not require a license under the previous Licensing By-law 1-2002.

The housekeeping by-law amendment will recognize the three (3) business locations existed and operated prior to the enactment of the Adult Entertainment Establishment By-law.
