

Public Notice

To Stop Up and Close a Portion of the Road Allowance and Declare Surplus to the Municipality's Requirements Lands Known as Block 585, Plan 43M-1550 Corner of Creditview Road and Buick Boulevard

PURSUANT to By-law 160-2004, take notice that The Corporation of the City of Brampton intends to undertake the following:

• Stop up and close a portion of the road allowance and declare surplus to the municipality's requirements the following municipal property:

LANDS AFFECTED

The municipal address is 0 Buick Boulevard and is located southeast of the intersection of Creditview Road and Buick Boulevard. The lands to be declared surplus total 0.14 acres in size.

The property PIN is 14366-2620 (LT).

EXPLANATORY NOTE

The City became the registered owner of 0 Buick Boulevard on September 23, 2013, when Instrument No. PR2436524 was electronically registered in the Land Registry Office. On November 20, 2013, Council passed By-Law 318-2013, and established this land as part of the public highway system to be part of Creditview Road. The City has now identified this parcel as surplus to the needs of the municipality.
