

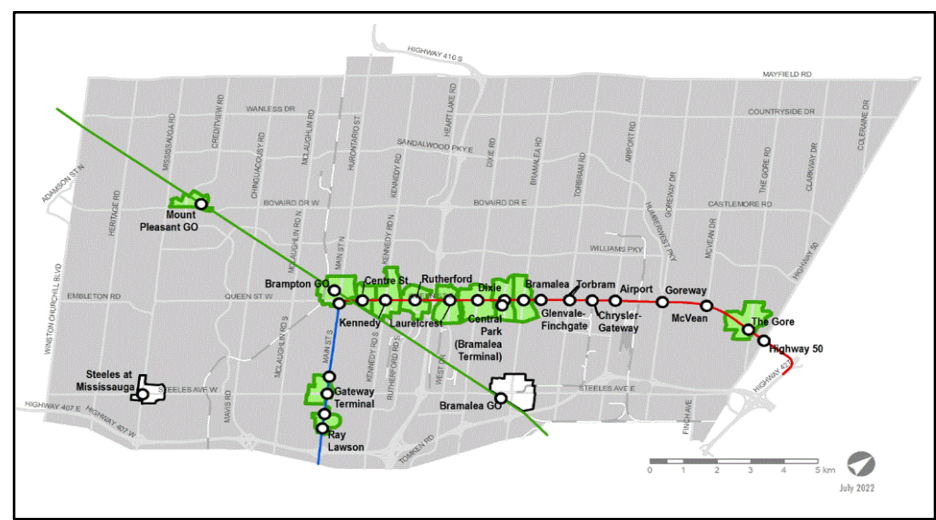
Brampton's Major Transit Station Area Study



Brampton is Canada's ninth largest city and the fastest growing of the country's twenty-five largest cities. The Province of Ontario is directing growth to areas of Brampton that can support it. These areas include Major Transit Station Areas (MTSAs).

We are creating land use plans and policies to guide how each of Brampton's "Primary" MTSA's (shown in green on the map below) will grow and evolve in the future. The goal is to support the achievement of 'complete communities' through a compact built form and mix of land uses that are planned and designed to be walkable and transit-supportive.

What is a Major Transit Station Area (MTSA)?

MTSAs are higher density, mixed-use, transit-supportive neighbourhoods that provide easy access to local amenities, jobs, housing, and recreation opportunities. MTSAs include lands within a 500-800 metre radius (10-minute walk) of a transit station or stop. They are located primarily along existing or planned transit corridors (e.g. GO Train, Light Rail Transit, Bus Rapid Transit).
