Notice of Refusal of Application to Amend the Official Plan and Zoning By-law, Gagnon Walker Domes Ltd. – Rotary Club of Brampton Community Centre, 1857 Queen Street West, Ward 4, File: OZS-2021-0018

Date of Decision: March 1, 2023
Date of Notice: March 13, 2023
Last Date of Appeal: April 3, 2023

On the date noted above, the Council of the Corporation of the City of Brampton refused an application to amend the Official Plan and Zoning By-law under sections 22 (6.6) and 34 (10.9) of the *Planning Act*, RSO 1990 c.P.13, pursuant to an application by Gagnon Walker Domes Ltd. – Rotary Club of Brampton Community Centre, 1857 Queen Street West, Ward 4, File: OZS-2021-0018 for the following reasons:

- a. The form of the development is not compatible with the character of the surrounding area;
- b. The proposed height and density are not consistent with the other developments within the Queen Street West Tertiary Plan;
- c. The proposed development will create undue negative impacts on the surrounding community;
- d. The lack of consideration by the applicant of the input on the application received from the public; and,
- e. Uncertainty about the proposed use as to whether it would be for seniors housing or another type of residential use.

An explanation of the purpose and effect of the proposed amendments is provided. The decision of Council is final if a notice of appeal is not received on or before the last day for filing an appeal.

The Purpose and Effect: to amend the Official Plan and Zoning By-law 270-2004, as amended, pursuant to an application by Gagnon Walker Domes Ltd. – Rotary Club of Brampton Community Centre, 1857 Queen Street West, Ward 4, File: OZS-2021-0018 to facilitate the development of two multi-storey residential apartment buildings, having heights of twelve and fourteen storeys.

Location of Lands Affected: 1857 Queen Street West – South side of Queen Street West, east of Mississauga Road– Ward 4

Any and all written submissions relating to this application that were made to Council and the Planning and Development Committee before its decision and any and all oral submissions related to this application that were made at a public meeting, held under the *Planning Act*, have been, on balance, taken into consideration by Council as part of its deliberations and final decision on this matter.

A person or public body that requested an amendment to the Official Plan and Zoning Bylaw of the City of Brampton may appeal the refusal of the requested amendments to the Ontario Land Tribunal (OLT) in respect of all or any part of the requested amendments by filing a notice of appeal with the Clerk of the City of Brampton, **no later than April 3, 2023.** An appeal form is available from the OLT website at https://olt.gov.on.ca/tribunals/lpat/forms/

The Notice of Appeal must:

- (1) set out the reasons for appeal; and,
- (2) be accompanied by the fee required by the OLT in the amount of \$1,100.00, each payable by certified cheque or money order to the Minister of Finance, Province of Ontario. A copy of the Fee Schedule may be found at https://olt.gov.on.ca/tribunals/lpat/lpat-process/fee-chart/.

No person or public body shall be added as a party to the hearing of the appeal unless, before the requested Official Plan and Zoning By-law amendments were refused, the person or public body made oral submissions at a public meeting, if any, or written submissions to the council or, in the opinion of the OLT there are reasonable grounds to add the person or public body as a party.
