



#### **Purpose and Effect**

The proposed Draft Plan of Subdivision consists of fifty (50) single detached lots and a local public road with a right-of-way width of 17 metres. The subject property was planned to be a school site; however, the Dufferin-Peel Catholic School Board has declared the lands surplus for their needs. Additionally, the Peel School Board and the City have indicated that they do not have an interest in the property.

#### **Proposal highlights**

- The subject property is located at the southwest corner of Valleyway Drive and Brentwick Drive.
   It is legally described as Block 301 on Registered Plan 43M-1920.
- The lands are dual-zoned to permit a School or Residential Single Detached dwellings.
- The subject property is approximately 2.602 ha in size.

**Note**: In accordance with Official Plan policy, a recommendation report will be prepared by staff and presented to a future meeting of the Planning and Development Committee and forwarded to City Council for a decision. City Council will not adopt a proposed Official Plan Amendment or enact a proposed Zoning Bylaw or approve in principle a plan of subdivision until at least 30 days after the date of a statutory public meeting.


#### Important Information about making a submission

If a person or public body does not make oral submissions at a public meeting or make written submissions to the City of Brampton with respect to a proposed plan of subdivision, proposed official plan amendment or proposed zoning by-law amendment before the City gives or refuses to give approval to the draft plan of subdivision, or before a zoning by-law is passed, or before a proposed official plan amendment is adopted:

- (a) The person or public body is not entitled to appeal the decision of the City of Brampton to the Local Planning Appeal Tribunal; and,
- (b) The person or public body may not be added as a party to the hearing of an appeal before the Local Planning Appeal Tribunal unless, in the opinion of the Tribunal, there are reasonable grounds to do so.




