


Purpose and Effect

An application has been submitted to amend the Official Plan and Zoning By-law to further develop a 1.6 hectare site by adding a 9-storey mixed-use building.

The property is located at 25 Kings Cross Road.

Proposal Highlights

- A new apartment building 9-storeys in height;
- A total of 144 residential units;;
- Approximately 1,808 square metres of new ground floor commercial space within the new mixed-use building;
- The existing one-storey, 6,444 square metre commercial building currently located on the property is to remain; and,
- 334 parking spaces.

Note: In accordance with Official Plan policy, a recommendation report will be prepared by staff and presented to a future meeting of the Planning and Development Committee and forwarded to City Council for a decision. City Council will not adopt a proposed Official Plan Amendment or enact a proposed Zoning Bylaw or approve in principle a plan of subdivision until at least 30 days after the date of a statutory public meeting.

Important Information about making a submission

If a person or public body does not make oral submissions at a public meeting or make written submissions to the City of Brampton with respect to a proposed plan of subdivision, proposed official plan amendment or proposed zoning by-law amendment before the City gives or refuses to give approval to the draft plan of subdivision, or before a zoning by-law is passed, or before a proposed official plan amendment is adopted:

(a) The person or public body is not entitled to appeal the decision of the City of Brampton to the Local Planning Appeal Tribunal; and,

(b) The person or public body may not be added as a party to the hearing of an appeal before the Local Planning Appeal Tribunal unless, in the opinion of the Tribunal, there are reasonable grounds to do so.
