

Purpose and Effect:

The applicant has submitted an application to amend the Official Plan and Zoning By-Law in order to convert the westerly building of the subject property (Building A of the Concept Plan) to a supermarket and an accessory outdoor seasonal garden centre. The garden centre will be located on the north side of the supermarket and will occupy 25 of the existing parking spaces. The existing solid waste collection containers will be relocated within the parking area. A new blanket ratio for the parking calculation is also proposed at 1 space per 23 square metres (247.57 square feet) of commercial GFA for the entirety of the site.

This building has a gross floor area of 3,320.64 square metres (35,743 square feet) and it will remain unchanged. Structural elements and the exterior design of the building will remain in its current configuration.


Important Information about making a submission

If a person or public body does not make oral submissions at a public meeting or make written submissions to the City of Brampton with respect to a proposed official plan amendment or proposed zoning by-law amendment before a zoning by-law is passed, or before a proposed official plan amendment is adopted:

- (a) The person or public body is not entitled to appeal the decision of the City of Brampton to the Local Planning Appeal Tribunal; and.
- (b) The person or public body may not be added as a party to the hearing of an appeal before the Local Planning Appeal Tribunal unless, in the opinion of the Tribunal, there are reasonable grounds to do so.






