### Purpose and Effect

The purpose of the application is to rezone the property at 25 William Street for residential townhouse and open space purposes. The application also proposes to amend the Downtown Brampton Secondary Plan to allow stacked townhouses and increase the permitted density above the maximum under the Medium Density designation that applies to the site currently.

### Proposal highlights:

- One townhouse block with 12 dwelling units
- 15 parking spaces
- The extension of William Street
- Environmental lands with associated buffers in the southern part of the site

### Important Information about making a submission

If a person or public body does not make oral submissions at a public meeting or make written submissions to the City of Brampton with respect to a proposed plan of subdivision, proposed official plan amendment or proposed zoning by-law amendment before the City gives or refuses to give approval to the draft plan of subdivision, or before a zoning by-law is passed, or before a proposed official plan amendment is adopted:

- The person or public body is not entitled to appeal the decision of the City of Brampton to the Local Planning Appeal Tribunal; and,
- The person or public body may not be added as a party to the hearing of an appeal before the Local Planning Appeal Tribunal unless, in the opinion of the Tribunal, there are reasonable grounds to do so.
