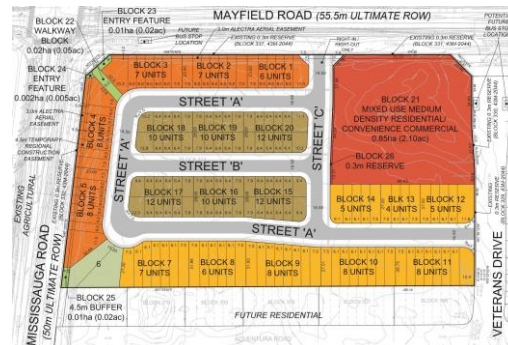

Purpose and Effect

This application proposes to amend the Official Plan and Zoning By-law to develop the lands through a draft plan of subdivision for approximately 155 units comprising townhouses and semi-detached dwellings and a mixed-use medium density residential/convenience commercial block at the intersection of Mayfield Road and Veterans Drive. The submitted Official Plan Amendment proposes to amend the Official Plan, Mount Pleasant Secondary Plan and Mount Pleasant Secondary Block Plan to re-designate the property from “Neighbourhood Retail, Neighbourhood Commercial” and “Motor Vehicle Commercial” to “Medium Density Residential”, “Convenience Retail, “Convenience Commercial” and “Mixed Use”. The submitted Zoning By-law amendment proposes to implement the townhouse and semi-detached uses on the proposed subdivision plan and to zone the mixed-use medium density residential/convenience commercial for retail and commercial uses and residential uses including a mid-rise apartment with ground floor retail/commercial and a retirement residence.



If you have received this notice as an owner of a property and the property contains 7 or more residential units, the City requests that you post this notice in a location that is visible to all the residents, such as on a notice board in the lobby.

Important Information about making a submission

If a person or public body does not make oral submissions at a public meeting or make written submissions to the City of Brampton with respect to a proposed plan of subdivision, proposed official plan amendment or proposed zoning by-law amendment before the City gives or refuses to give approval to the draft plan of subdivision, or before a zoning by-law is passed, or before a proposed official plan amendment is adopted:

- (a) The person or public body is not entitled to appeal the decision of the City of Brampton to the Local Planning Appeal Tribunal; and,
- (b) The person or public body may not be added as a party to the hearing of an appeal before the Local Planning Appeal Tribunal unless, in the opinion of the Tribunal, there are reasonable grounds to do so.

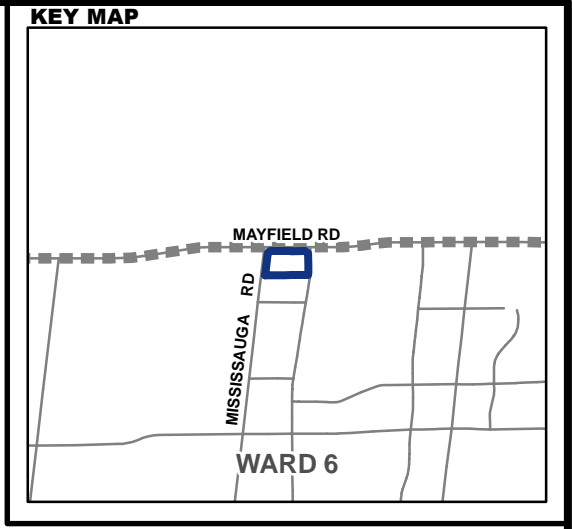

Note: In accordance with Official Plan policy, a recommendation report will be prepared by staff and presented to a future meeting of the Planning and Development Committee and forwarded to City Council for a decision. City Council will not adopt a proposed Official Plan Amendment or enact a proposed Zoning By-law or approve in principle a plan of subdivision until at least 30 days after the date of a statutory public meeting.

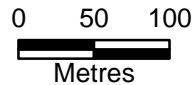
