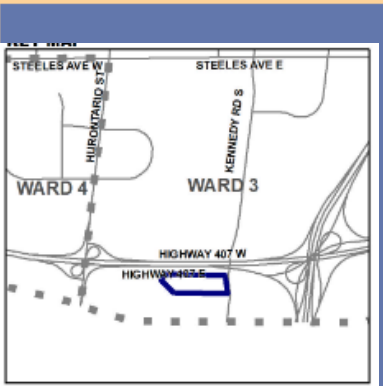

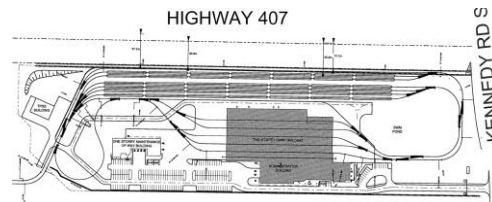

Purpose and Effect

The purpose of this application is to rezone the lands to permit the development of the Province's Operations, Maintenance and Storage Facility (OMSF) including administrative headquarters for the Hurontario Light Rail Transit Project. The City's Public Works and Engineering Department, on behalf of the Province, are preparing the necessary land use permissions to facilitate this project.

The site is located south of Highway 407 / ETR and west of Kennedy Road.

Attached below is a conceptual plan showing the possible location of the proposed buildings, parking, tracks and storage area of the light rail vehicles. The actual design will be undertaken by the proponent that will be selected to lead the process of designing, building, financing, operating and maintaining the light rail transit system along Hurontario Street.



If you have received this notice as an owner of a property and the property contains 7 or more residential units, the City requests that you post this notice in a location that is visible to all the residents, such as on a notice board in the lobby.

Important Information about making a submission

If a person or public body does not make oral submissions at a public meeting or make written submissions to the City of Brampton with respect to a proposed plan of subdivision, proposed official plan amendment or proposed zoning by-law amendment before the City gives or refuses to give approval to the draft plan of subdivision, or before a zoning by-law is passed, or before a proposed official plan amendment is adopted:

- The person or public body is not entitled to appeal the decision of the City of Brampton to the Local Planning Appeal Tribunal; and,
- The person or public body may not be added as a party to the hearing of an appeal before the Local Planning Appeal Tribunal unless, in the opinion of the Tribunal, there are reasonable grounds to do so.

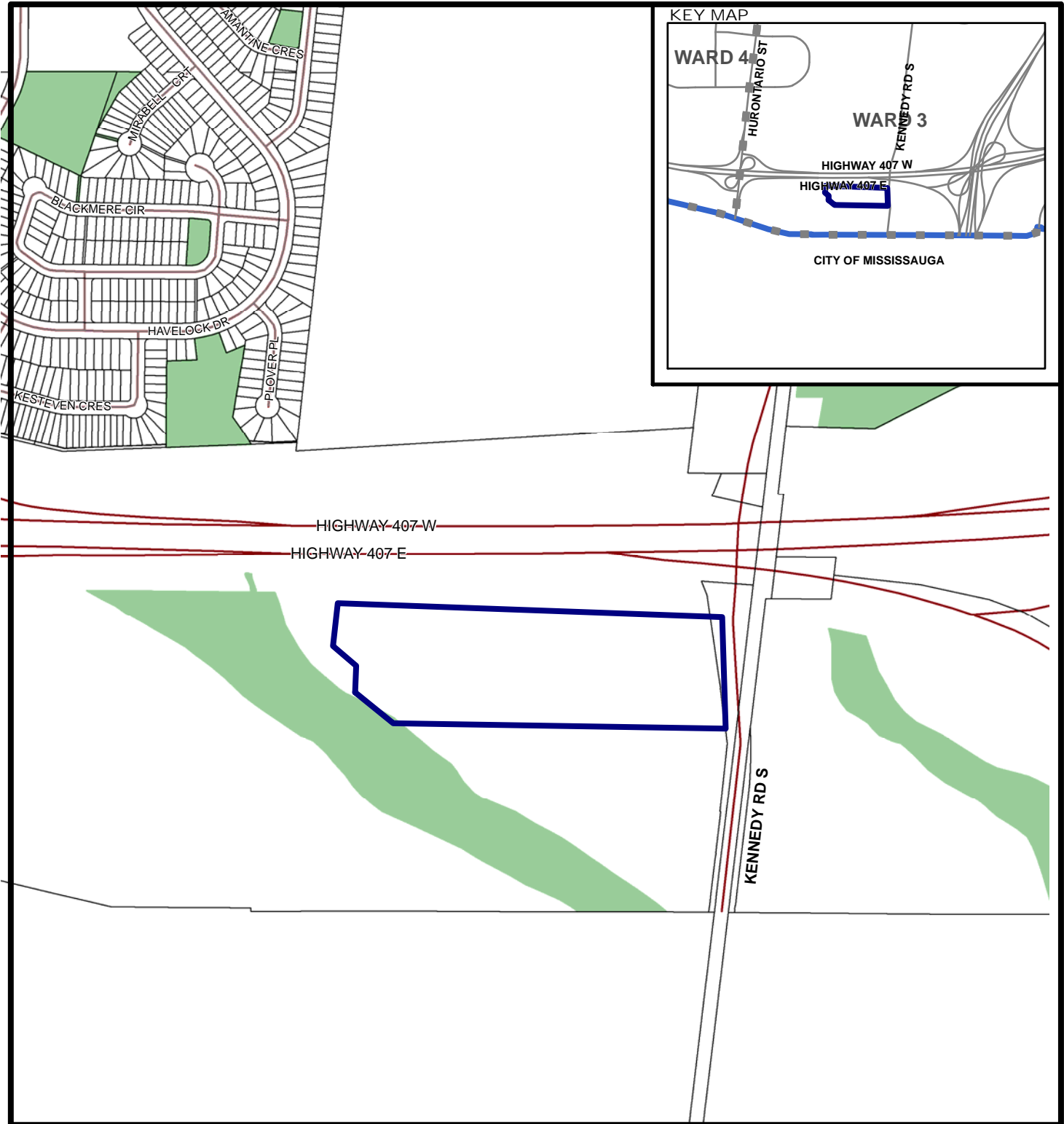

Note: In accordance with Official Plan policy, a recommendation report will be prepared by staff and presented to a future meeting of the Planning and Development Committee and forwarded to City Council for a decision. City Council will not adopt a proposed Official Plan Amendment or enact a proposed Zoning By-law or approve in principle a plan of subdivision until at least 30 days after the date of a statutory public meeting.
