



# Notice of Passing of Zoning By-law 32-2024

### **Below Grade Entrances**

### City-wide

# Date of Decision: February 28, 2024 Date of Notice: March 13, 2024 Last Date of Appeal: April 2, 2024

On the date noted above, the Council of the Corporation of the City of Brampton passed By-law 32-2024, to amend Zoning By-law 270-2004, as amended, under Section 34 of the *Planning Act,* R.S.O., c.P.13, pursuant to a City-Initiated application.

The Purpose and Effect of the Zoning By-law: To allow for below grade entrances in the exterior side yard on residential lots.

**Location of Lands Affected:** The Zoning By-law amendment is City-wide and will affect all residential lots.

Any and all written submissions relating to this amendment that were made to Council, and the Planning and Development Committee, before its decision and any and all oral submissions related to these applications that were made at a public meeting, held under the *Planning Act*, have been, on balance, taken into consideration by Council as part of its deliberations and final decision on these matters.

# **Public Notice**

# The Notice of Appeal must:

- (1) set out the reasons for appeal; and,
- (2) be accompanied by the fee required by the Ontario Land Tribunal in the amount of \$1,100.00 payable by certified cheque or money order to the Minister of Finance, Province of Ontario. A copy of the Ontario Land Tribunal Fee Schedule may be found at <u>https://olt.gov.on.ca/appeals-process/fee-chart/</u>

Only individuals, corporations and public bodies may appeal a by-law to the Ontario Land Tribunal (OLT). A notice of appeal may not be filed by an unincorporated association or group. However, a notice of appeal may be filed in the name of an individual who is a member of the association or the group on its behalf.

No person or public body shall be added as a party to the hearing of the appeal unless, before the by-law was passed, the person or public body made oral submissions at a public meeting or written submissions to the Council or, in the opinion of the Ontario Land Tribunal, there are reasonable grounds to add the person or public body as a party.

THE CORPORATION OF THE CITY OF BRAMPTON **BY-LAW** *Number* <u>32</u> - 2024 To amend Comprehensive Zoning By-law 270-2004, as amended The Council of The Corporation of the City of Brampton, in accordance with the provisions of the Planning Act, R.S.O. 1990, c.P. 13, hereby ENACTS as follows: 1. By-law 270-2004, as amended, is hereby further amended: (1) By amending Section 10.23, Below Grade Exterior Stairs and Windows, as follows: a) by deleting Section 10.23.1 in its entirety and replacing it with the following new section: "10.23.1 For a single detached, semi-detached, or townhouse dwelling, or two unit dwelling, exterior stairways constructed below the established grade shall not be located in a required side yard or front yard." ENACTED and PASSED this 28<sup>th</sup> day of February, 2024.
