
Purpose and Effect

An application has been submitted for a proposed draft plan of subdivision to permit townhouse and semi-detached units.

Proposal highlights:

The proposed draft plan of subdivision consists of the following:

- 118 townhouse dwellings;
- 4 semi-detached residential dwellings:
- A Walkway Block;
- A Daylight Triangle Block;
- 2 Buffer Blocks;
- A Road Widening Block; and,
- A municipal road system with a proposed alternative design standard.

Note: In accordance with Official Plan policy, a recommendation report will be prepared by staff and presented to a future meeting of the Planning and Development Services Committee and forwarded to City Council for a decision. City Council will not adopt a proposed Official Plan Amendment or enact a proposed Zoning By-law or approve in principle a plan of subdivision until at least 30 days after the date of a statutory public meeting.


Important Information about making a submission

If a person or public body does not make oral submissions at a public meeting or make written submissions to the City of Brampton with respect to a proposed plan of subdivision, proposed official plan amendment or proposed zoning by-law amendment before the City gives or refuses to give approval to the draft plan of subdivision, or before a zoning by-law is passed, or before a proposed official plan amendment is adopted:

- (a) The person or public body is not entitled to appeal the decision of the City of Brampton to the Ontario Municipal Board; and,
- (b) The person or public body may not be added as a party to the hearing of an appeal before the Ontario Municipal Board unless, in the opinion of the Board, there are reasonable grounds to do so.
