

## Help Us Serve Our City City of Brampton Citizen Appointments - Current Vacancies

The Council of the Corporation of the City of Brampton is currently seeking applications from citizens interested in being appointed to serve on one of the following committees for the remainder of the 2018-2022 term of Council, ending in November 2022, or until a successor is appointed.

### **Brampton Transit Advisory Committee: Five (5) positions**

(One resident from each ward pairing to represent the community at large for a total of five citizen appointments, to meet approximately **four times per year**)

### **Vehicle-for-hire Advisory Committee: Fourteen (14) positions**

(Eight taxicab industry representatives, including two taxicab plate owners who are not taxicab brokers; four taxicab drivers who are not plate owners; two taxicab brokers on recommendation by the licensed taxicab brokers;

Two Limousine plate owners;

Two private transportation company (PTC) representatives; and

Two citizen appointments who do not work in the taxicab industry and are residents of Brampton; to meet approximately **twice per year**)

### **Brampton Heritage Board: One (1) position**

(One resident from within the Churchville Heritage Conservation District, to meet **monthly**)

### **Greater Toronto Airports Authority (GTAA) Consultative Committee: One (1) position** (One resident of Brampton, for approximately **four meetings per year**)

Personal and pecuniary interests may include the potential for personal or financial gain for the committee member or someone they are associated with, such as a family member, employer or business partner. The provisions of the [Municipal Conflict of Interest Act](#), apply to all committee members. Among other things, the *Act* requires that if a matter in which you have an interest comes before the committee, you must declare your interest openly and refrain from taking part in, or influencing in any way, the debate on the matter.
