Public Engagement Summary



1 Introduction

1.1 Purpose of Public Workshop

1.1.1 Purpose

On Wednesday June 16th, 2021, from 6:00 pm to 8:00pm, a Seniors and Accessibility Focus Group was held for the City of Brampton Official Plan Review focusing on Brampton Plan. The purpose of the meeting was to provide an overview of the Official Plan Review project, engagement events held to date, and provide information on how to further participate in the process. It was also an opportunity to collaborate and engage in open discussion to address the key themes related to the City's draft Official Plan Structure. The event was organized as follows (see Appendix A – Meeting Agenda):

Part 1 - Introduction and Housekeeping: Indigenous land acknowledgement; introductions and welcome statements. City staff reviewed the meeting objectives.

Part 2 - Presentation: City staff provided an overview of key Official Plan drivers, structure maps, and performed live voting/poll questions.

Part 3 - Discussion: Public engagement poll period.

Part 4 - Next Steps: Survey and discussed other ways to provide feedback.

1.2 Meeting Overview

1.2.1 Meeting Details (Venue, # of Attendees, Meeting Participants)

Approximately 10 members of the public and 6 City of Brampton Staff attended the Focus Group Meeting that was hosted on WebEx. Comments were received through the WebEx chat box. Interactive poll questions were posed during the presentation to gain a better understanding of the participants and allow them to vote for characteristics that they believed contributed to their idea of a healthy and complete community, as well as areas of social equity they wish Brampton Plan policies should focus on.

1.3 Outreach

The meeting was promoted through email circulation towards The Brampton Age-Friendly Advisory Committee and Accessibility Advisory Committee, and among other various Seniors organizations such as the CARP, Brampton Seniors Council, etc.



2 Feedback

2.1 Polling Questions

Interactive polling questions were posed during the public meeting presentation to obtain a better understanding of the participants and what they believed are important characteristics of healthy and complete communities. The full poll results can be found in Appendix B.

Based on the input received, the city-building themes participants were most interested in discussing were: Social Equity, Attainable and Supportive Housing (44%) followed by Arts, Culture and Events (33%) and Urban Design, Open Spaces and Recreation (33%). Participants also selected Growth (22%) and Transportation and Connectivity (22%). A smaller percentage of participants selected Natural Heritage, Climate Change and Resiliency (11%), Employment and Retail (11%) and Heritage Preservation (11%). A third of participants (33%) omitted an answer for this question.

The polling questions included choosing the characteristics in which participants believed contributed to healthy and complete communities. The options provided were as follows:

- Active Transportation (i.e. walking, cycling, transit);
- · Creating affordable housing and different housing options for all stages of life;
- Creating a connected and accessible network of green spaces (i.e. parks, trails, natural areas);
- Having a variety of employment areas and jobs;
- Equitable access to community services and facilities (i.e. libraries, rec centres, parks;)
- Ensuring a community has places to live, work, exercise, and play and buy local healthy foods;
- All of the above; and,
- Other

Almost half of the participants (40%) voted that all the characteristics contribute to a healthy and complete community. This response was followed by active transportation options—such as walking, cycling and transit (30%), creating affordable and different housing types (20%), creating a connected and accessible network of green spaces (20%). ensuring a community has places to live, work, exercise, play and buy local and healthy foods (20%), and having equitable access to community services and facilities—such as libraries, recreation centers and parks (10%). Thirty percent (30%) of respondents did not select an answer to this question.

Participants were asked what areas of social equity that Brampton should prioritize in the long-term. About half of respondents (55%) believe that Brampton should prioritize housing and affordability, followed by social services (40%). Jobs and employment followed (30%) along with transit and transportation methods (30%) and then the health sector (20%). Ten percent (10%) of respondents believed that access to green spaces should be prioritized, while only five percent (5%) of participants selected food equity. Ten percent (10%) of respondents declined to answer.





Public Engagement Summary

A final poll question asked which listed housing policy areas would have the biggest impact for seniors and accessibility. A wide range of Seniors-Oriented Housing (60%) and family-friendly apartments (50%) received the highest votes. Accessible and adaptable housing followed at thirty percent (30%). Next was lodging houses and other rentals for singles (20%) and mixed-use developments (20%). Forty percent (40%) of participants chose to not respond to this question.

3 Key Messages Heard

3.1 Attainable and Supportive Housing



3.1.1 Affordability

- Employing city funds and non-profit developers to create cost-effective and affordable housing (Housing Catalyst Capital Projects).
- Lower-rise multi-use housing that are both visually appealing and which use land efficiently.
- Single Room Occupancy Buildings that provide cheaper and supportive living space for single people of various demographics, such as elderly and students.

3.1.2 Diverse Range of Seniors-Oriented Housing

 Providing a wide array of options for seniors to live how they would like: be it with their relatives in family-friendly homes and apartments, senior-assisted living or on their own.

3.1.3 Support for Senior Citizens

- Funding and resources placed to assist seniors when needed in whatever housing options they choose for themselves.
- Providing necessary assistance and support to senior citizens who choose to stay in their original homes (National Housing Strategy).
- Maintain communication with the Social Support Task force and continued implementation of the Age-friendly Strategy to best ensure needs are met.





• Ensure constant input and engagement with citizenry is in place to best serve the needs of the community.

3.1.4 Safety

- Concern about loitering from youth and marginalized individuals, with some individuals feeling increasingly less safe in their homes and communities.
- Increased support required to counter marginalization and homelessness.

Arts, Equity & Cultural Heritage 3.2



3.2.1 Arts/Culture

- Host community events and encourage practice of culture.
- Encourage recreation in the city for seniors.
- Ensure that the revitalization effort for the Brampton Heritage Theatre is successful in turning it into a useful instrument for the community of all ages and abilities.

3.2.2 Equity

- Ensure cultural groups are engaged with in an appropriate manner.
- Employ the usage of census data to best inform policy.
- Ensure all communities have ample access to high quality food, and of a high variety to best accommodate all cultural and culinary practices.
- Provide options for homecare as well as long-term care homes, to best account for individual and cultural preferences and needs.

Open Spaces and the Environment 3.3



3.3.1 Creating Equitable Access to Green Spaces in the City

- Ensuring every neighborhood and community has ample access to quality parks, greenery and recreation spaces.
- Encouraging the development of green roofs.
- Mixed-use developments with residential, office, commercial and public spaces integrated together, to best ensure accessibility and walkability for citizens.

Growth and Urban Design 3.4



3.4.1 Downtown Revitalization

- Concern expressed over timeline of downtown development.
- Ensure an accessibility lens is applied in the redevelopment of downtown revitalization infrastructure.
- Ensure the negative effects of construction and development throughout the downtown corridor is alleviated to best maintain safety and quality of life.





Public Engagement Summary

 Concern over road closures and lane reductions as the Downtown expands and as the LRT network is built. Pedestrian and traffic safety should be prioritized during such expansions.

3.4.2 Growth

• Ensure high quality, inclusive and accessible communities are developed as the city expands.
