

Report on the Financial Statement

We have audited the accompanying financial statement – auditor's report candidaté – Form 4 of the Nishi Sidhu Campaign.

Candidate's Responsibility for the Financial Statement

The Candidate is responsible for the preparation and fair presentation of this financial statement in accordance with Accounting procedures established by the Municipal Elections Act, 1996, and for such internal control as Candidate determines necessary to enable the preparation of financial statement that is free from material misstatement, whether due to fraud or error.

Auditor's Responsibility

Our responsibility is to express an opinion on this financial statement based on our audit. We conducted our audit in accordance with Canadian generally accepted auditing standards. Those standards require that we comply with ethical requirements and plan and perform the audit to obtain reasonable assurance about whether the financial statement is free from material misstatement.

An audit involves performing procedures to obtain audit evidence about the amounts and disclosures in the financial statement. The procedures selected depend on the auditor's judgment, including the assessment of the risks of material misstatement of the financial statement, whether due to fraud or error. In making those risk assessments, the auditor considers internal control relevant to the Candidate's preparation and fair presentation of the financial statement in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Candidate's internal control. An audit also includes evaluating the appropriateness of accounting policies used and the reasonableness of accounting estimates made by the Candidate, as well as evaluating the overall presentation of the financial statement.

We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

Basis for Qualified Opinion

Due to the nature of the types of transactions inherent in an election campaign, it is impracticable through auditing procedures to determine that the accounting records include all donations of goods and services, and receipts and disbursements. Accordingly, our examination of these transactions was limited to ensuring that the financial statement reflects the amounts recorded in the accounting records of the Candidate in accordance with the accounting procedures established by the Municipal Elections Act, 1996, and we were not able to determine whether any adjustments might be necessary to income, expenses, surplus or deficit.

Qualified Opinion

In our opinion, except for the possible effect of adjustments, if any, which might have been determined to be necessary, had we been able to satisfy ourselves as to the completeness of the records as described in the Basis for Qualified Opinion paragraph above, this financial statement present fairly, in all material respects, the financial position of Candidate's election campaign as at December 31, 2018 and the income and expenses for the campaign for the period June 28, 2018 to December 31, 2018 in accordance with the accounting treatment prescribed by the Municipal Elections Act, 1996.
