Heritage Heights Transportation Master Plan

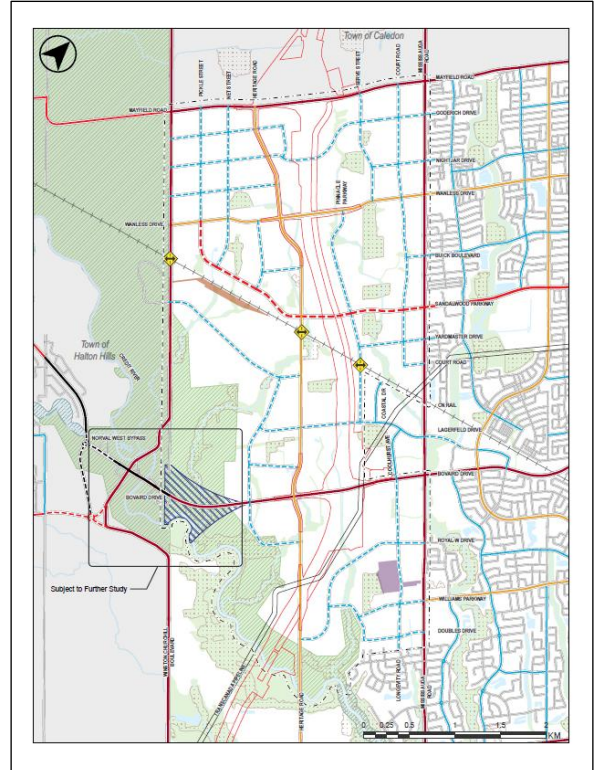
The Transportation Master Plan

The City of Brampton is experiencing significant growth including in the Heritage Heights Secondary Plan Area. The City of Brampton and the Heritage Heights Landowners Group worked together as co-proponents to complete a Transportation Master Plan (TMP) to identify the transportation infrastructure required to support the growth envisioned for the Heritage Heights Secondary Plan Area (see figure for study area). The TMP provides the long-range planning necessary to identify needs, be active transportation (e.g., cycling, trails) friendly and transit supportive, promote mobility, and provide a planning framework that is compatible with new and existing communities and keeps pace with future growth.

The Process

The TMP was undertaken in accordance with Approach #2 of the Master Planning Process, as outlined in the Municipal Class Environmental Assessment (MCEA) (February 2024). As such, the TMP addressed Phases 1 and 2 of the MCEA process for any Schedule B projects and forms the basis for the recommended Schedule C transportation infrastructure projects identified within the TMP report.

The related Schedule B and C collector road projects are identified for each Precinct as well as the Schedule C arterial road projects and they are all identified in "Table 15 City Infrastructure Project List" of the **Heritage Heights Secondary Plan – Transportation Master Plan (February 9, 2026)**.



Environmental Study Report

The Environmental Study Report will be available for a 30-day public comment period starting **February 9, 2026** and ending **March 11, 2026**, in accordance with the requirements of the Municipal Class EA process (MCEA, February 2024).
