# Municipal Class Environmental Assessment - Schedule C Heritage Heights Block 52-1 - Royal West Drive and Longevity Road

#### The Study

The City of Brampton is experiencing significant growth including in the Heritage Heights
Secondary Plan Area. A Transportation Master Plan (TMP) was undertaken to identify the transportation infrastructure required to support the growth envisioned for the Heritage Heights
Secondary Plan Area. For Heritage Heights
Block 52-1, two collector roads have been identified that require additional study. The two collector roads are Royal West Drive (Mississauga Road to Heritage Road) and Longevity Road (existing Longevity Road to Bovaird Drive) (see highlighted roads in figure).

As a result, a Schedule 'C' Class Environmental Assessment (EA) under the Municipal Class EA process (Feb 2024) has been initiated by the Block 52-1 (Heritage Heights) Landowners Group Inc. as the proponent of the Study. The City of Brampton will be a key stakeholder in this Study. The purpose of the Schedule C Study will be to identify design solutions for the two collector roads.



As part of the Study, online public engagement and technical agency consultation will be undertaken to allow local residents and interested members of the public the first opportunity to review and comment on the design options. It is anticipated that one Online Public Engagement (OPE) will be provided during the study.

## **Online Public Engagement**

To ensure that those interested in this Study have an opportunity to provide input to and receive feedback from the Study team, an Online Public Engagement will be conducted as outlined below. This OPE will include presentation materials that are available online and present study background information, design solutions considered, evaluation of design alternatives, selection of the recommended design, mitigation measures and next steps in the study process.
