# **BY-LAW**

Number 183-2010

To amend Traffic By-law 93-93 by amending the Consolidated Text and the Schedules relating to ATTENDANT CONTROLLED (TYPES OF PARKING LOTS), NO PARKING (PROHIBITED TURNS), AUTHORIZED RESIDENTIAL PARKING ZONES, FIRE ROUTES, RATE OF SPEED and DESIGNATED TURNING LANES

WHEREAS Subsection 11(3) of the *Municipal Act*, 2001 permits a local municipality to pass by-laws respecting highways, including parking and traffic on highways;

NOW THEREFORE the Council of the Corporation of the City of Brampton ENACTS as follows:

- 1. By-law 93-93 as amended, is hereby further amended as follows:
  - (1) by repealing and replacing the definition of a "parking machine" in PART I, Section 2 with the following definition:
    - "parking machine" means an electronic or mechanical device, for the purpose of controlling and regulating the parking of any motor vehicle in or on a parking lot.
  - (2) Section 57 (1) of the Traffic By-law 93-93 is repealed and replaced by the following.
    - 57. (1) The Commissioner is authorized to erect in or on any municipal parking lot such gates, attendant shelters, parking machines, signs and markers or other devices as may be necessary for the safe and efficient operation of such municipal parking lot.
  - (3) Section 57 (3) of the Traffic By-law 93-93 is repealed and replaced by the following.

#### 57. Authorization to Operate Parking Facilities

- The Commissioner, for the purpose of controlling and regulating parking in or on parking lots and for the purpose of measuring and recording the time during which a motor vehicle has been parked and the amount of fee to be collected, is hereby authorized to:
  - (a) erect, maintain and operate parking meters in or on those municipal parking lots set out in Schedule XXV of this by-law;
  - (b) erect, maintain and operate parking machines in or on those municipal parking lots set out in Schedule XXVI of this by-law;
  - (c) erect, maintain and operate parking machines or station attendants in or on those municipal parking lots set out in Schedule XXVII of this by-law,
  - (c) designate parking spaces in connection therewith;
  - (e) establish procedures for the issuance of monthly parking permits for the municipal parking lots set out in Schedule XXV, XXVI and XXVII of this by-law.

- (4) Section 57 (4) of the Traffic By-law 93-93 is repealed and replaced by the following:
  - 57. (4) Any person may obtain from the City a municipal parking lot permit to park a motor vehicle in a specified municipal parking lot for the current month or unexpired period thereof upon payment of the prescribed fee as set out in Schedules XXV, XXVI and XXVII of this by-law
- (5) Section 57 (7) of the Traffic By-law 93-93 is repealed and replaced by the following:

#### (7) Barrier gate controlled

- (a) No person shall park any motor vehicle in or on any municipal parking lot named and located in Columns 1 and 2 respectively of Schedule XXVII of this by-law during the hours of operation set out in Column 5 of said Schedule, unless:
  - (I) the fee is paid to the parking lot attendant or parking machine in accordance with the rate set out in Column 3 of said Schedule XXVII except that upon entrance to the lot from 5.00 p.m on New Year's Eve to 1:00 a m. on New Year's Day, a flat rate fee of \$20.00 is paid upon entry, said flat rate payment valid until the commencement of the first working day following New Year's day;
  - (II) the motor vehicle has a valid monthly permit purchased for the fee prescribed in Column 4 of said Schedule XXVII and the terms and conditions outlined regarding the use of the permit are adhered to.
  - (b) Despite sub-section (a), from 5:00 pm on New Year's Eve to 1:00 am on New Year's Day, a flat rate fee of Twenty Dollars (\$20.00) will apply upon entry to the parking lots located in Columns 1 and 2 which payments shall be valid until the commencement of the first working day following New Year's Day
- (6) by repealing the title of Schedule XXVII and replacing it with the following title: BARRIER CONTROLLED (TYPES OF PARKING LOTS).
- (7) by adding to Schedule XXVII thereto the following items
