
1. By-law 270-2004, as amended, is hereby further amended:

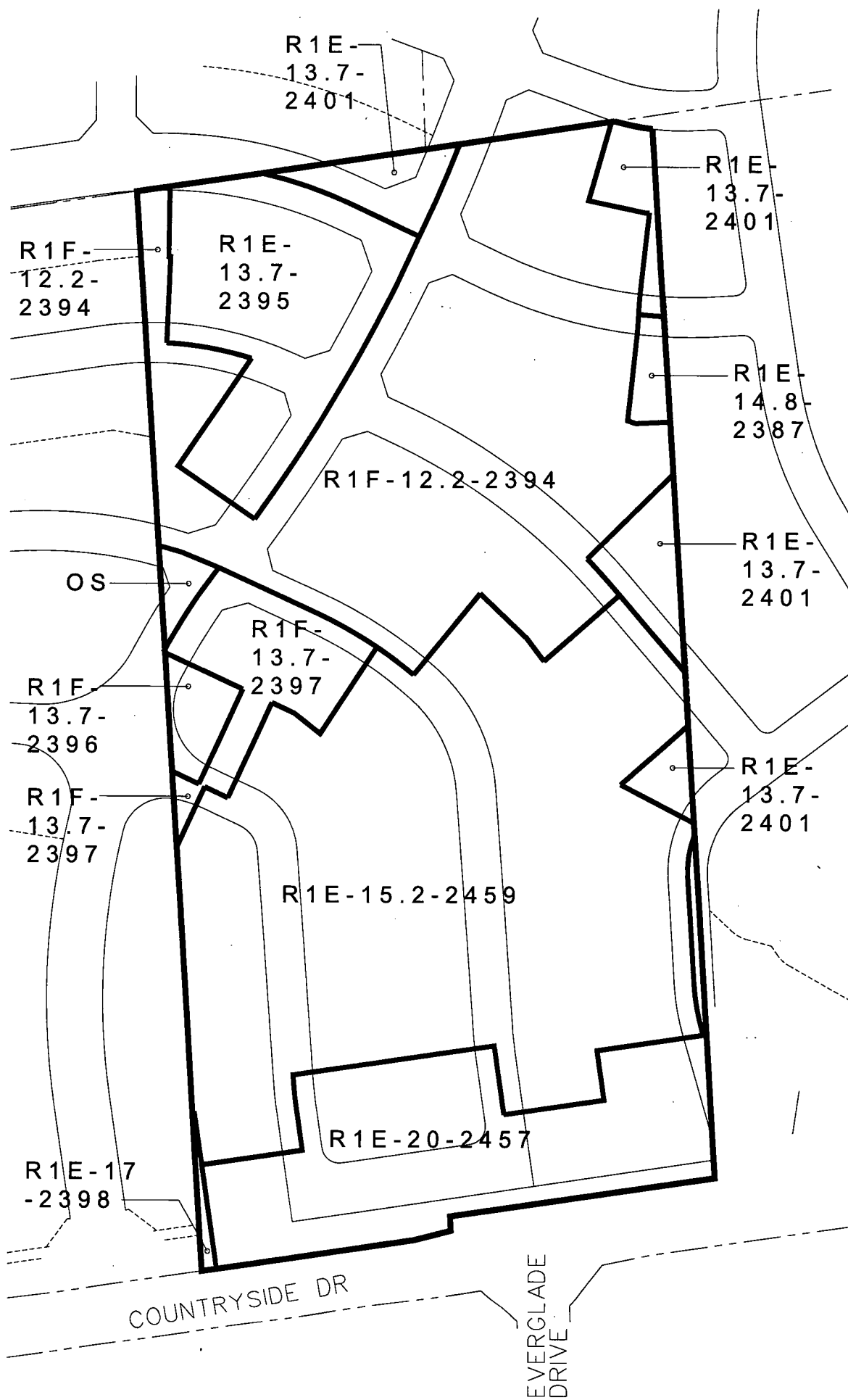

and say as follows:


1. I am the Deputy Clerk of The Corporation of the City of Brampton and as such
