# **BY-LAW**

A By-law to amend the Consolidated Text and Schedules of Traffic By-law 93-93, relating to INTERSECTION SIGHTLINE TRIANGLE (Schedule XLI), U-TURNS (Schedule II), NO STOPPING (Schedule XV), NO PARKING (Schedule XIV) SCHOOL BUS LOADING ZONES (Schedule VIII), FIRE ROUTES (Schedule XXII), ONE WAY TRAFFIC (Schedule I) and RATE OF SPEED (Schedule X)

The Council of The Corporation of the City of Brampton HEREBY ENACTS AS FOLLOWS:

- 1. By-law 93-93 as amended is hereby further amended by REPEALING "Schedule XXXX Intersection Sightline Triangle" from By-law 93-93 and by ADDING the attachment to this by-law called "Schedule XLI Intersection Sightline Triangle" as "Schedule XLI" of by-law 93-93, as amended.
- 2. Section 38.1 of By-law 93-93 is REPEALED and REPLACED by the following:

#### SIGHT LINE OBSTRUCTIONS ON PRIVATE PROPERTY

- 38.1 No property shall have a fence, retaining wall, vegetation, or any other encumbrance which encroaches into the vertical area contained within 0.914 and 2.4 metres above the finished grade of the abutting highways, and is within the triangular area indicated on Schedule XLI Intersection Sightline Triangle, attached to this bylaw. This triangular area shall be created by joining the following three points; the roadway point of intersection, the position of the stopped vehicle, and the sight distance clearance point, all as per Schedule XLI.
- 3. By-law 93-93 as amended, is hereby further amended by ADDING the following items to Schedule II:



## BY-LAW NO. <u>93-93</u> SCHEDULE XLI

#### INTERSECTION SIGHTLINE TRIANGLE

1. The following diagram illustrates the intersection sightline triangle.



Points of the Sight Triangle	Description		
Site Distance Clearance Points (A)	50 km/hour Major Road 90 metres		
	60 to 70 km /hour Major Road	120 metres	
Roadway Point of Intersection (B)	Point where the driver's position of the approach vehicle on the minor road intersects the edge of the outside travel lane of the major road.		
Position of Stopped Vehicle (C)	The driver's position of a vehicle stopped on the minor road. This point is set 4.5 metres back from the Roadway Point of Intersection (B).
