# BY-LAW

**A By-law to amend the Schedules of Traffic By-law 93-93, relating to NO STOPPING (Schedule XV), NO PARKING (Schedule XIV), FIRE ROUTES (Schedule XXII), DESIGNATED BICYCLE LANES (Schedule XXX) and SCHOOL BUS LOADING ZONES (Schedule VIII)**

The Council of the Corporation of the City of Brampton HEREBY ENACTS AS FOLLOWS:

1. By-law 93-93 as amended, is hereby further amended by ADDING the following items to Schedule XV:

**NO STOPPING**

COLUMN 1 HIGHWAY	COLUMN 2 SIDE	COLUMN 3 BETWEEN	COLUMN 4 TIMES OR DAYS
Gretna Drive	South	Kimbark Drive and a point 70 meters north of Kimbark Drive	Monday to Friday 7:00 a.m. to 9:00 a.m. and 2:00 p.m. to 4:00 p.m.

2. By-law 93-93 as amended, is hereby further amended by REMOVING the following items from Schedule XIV:

**NO PARKING**

Fletchers Creek Boulevard	West	Legacy Lane and a point 44 metres south of Binder Twine Trail	Anytime

5. By-law 93-93 as amended, is hereby further amended by DELETING the following items from Schedule VIII:

**SCHOOL BUS LOADING ZONE**

Earncliffe Circle	East	A point 136 metres east/south of Edenridge Drive (northerly intersection) and a point 276 metres east/south of Edenridge Drive (northerly intersection)	Earncliffe Senior Public School
