A By-law to amend the Schedules of Traffic By-law 93-93, relating to THROUGH HIGHWAYS (Schedule III), STOP SIGNS (Schedule IV), RATE OF SPEED (Schedule X), and NO PARKING (Schedule XV)

The Council of the Corporation of the City of Brampton HEREBY ENACTS AS FOLLOWS:

1. By-law 93-93, as amended, is hereby further amended by DELETING the following items from Schedule III:

The east limit of Delambray Street and the west limit of Ross Drive

Templehill Road

The east limit of Ross Drive and the west limit of Dixie Road

Pinestaff Road	40	Moonland Road/Havanna Crescent and Tappet Drive (southerly intersection)	Anytime
Ross Drive	40	Countryside Drive and Templehill Road	Anytime
Tappet Drive	40	McVean Drive and Pinestaff Road (southerly intersection)	Anytime


