

THE CORPORATION OF THE CITY OF BRAMPTON

BY-LAW

Number 209-2014

To exempt the property municipally known as
35 Ferndale Crescent from Interim Control By-Law 35-2013

The Council of The Corporation of the City of Brampton, in accordance with the provisions of the *Planning Act*, R.S.O. 1990, c.P. 13, hereby ENACTS as follows:

- 1. By-Law 35-2013, as amended, is hereby amended as follows:
 - 1.1 Section 1 is amended by adding after the words "Except as provided for in Section 1.1, Section 1.2, Section 1.3, Section 1.4, Section 1.5, Section 1.6, Section 1.7, Section 1.8, Section 1.9, Section 1.10, Section 1.11, Section 1.12, Section 1.13, Section 1.14, Section 1.15, Section 1.16, Section 1.17, Section 1.18, Section 1.19, Section 1.20, Section 1.21, Section 1.22, Section 1.23, Section 1.24, Section 1.25, Section 1.26, Section 1.27, Section 1.28 and Section 1.29" the following: "Section 1.30"
 - 1.2 The following is added as Section 1.30:
 - "1.30 On lands described as Concession 1 EHS, Lot 2 and referenced as the "Lands Subject to Specific Exemption From Interim Control By-Law 35-2013, as amended by By-Law 209-2014" and as shown on Schedule A to this by-law as 35 Ferndale Crescent, there shall be permitted an addition to the principle dwelling not exceeding 515 square feet."
- 2. Schedule A attached to this by-law is added as Schedule FF to Interim Control By-Law 35-2013, as amended.

READ a FIRST, SECOND AND THIRD TIME, and PASSED, in OPEN COUNCIL, this 67 day of August, 2014.


