A By-law to amend the Schedule of Traffic By-law 93-93, relating to NO PARKING (Schedule XIV) and NO STOPPING (Schedule XV)

The Council of The Corporation of the City of Brampton HEREBY ENACTS AS FOLLOWS:

1. By-law 93-93, as amended, is hereby further amended by DELETING the following items from Schedule XIV:

NO PARKING

COLUMN 1 HIGHWAY	COLUMN 2 SIDE	COLUMN 3 BETWEEN	COLUMN 4 TIMES OR DAY
Kesteven Crescent	East	A point 30 metres south of Havelock Drive (easterly intersection) and a point 35 metres south of Havelock Drive (easterly intersection)	8:00 a.m. to 5:00 p.m Monday to Friday September to June
Kesteven Crescent	Both	Havelock Drive (easterly intersection) and a point 100 metres southerly	Anytime
Peachwood Place	Both	Professor's Lake Parkway and the southerly limit	Anytime

2. By-law 93-93, as amended, is hereby further amended by ADDING the following items to Schedule XIV:

NO PARKING

COLUMN 1 HIGHWAY	COLUMN 2 SIDE	COLUMN 3 BETWEEN	COLUMN 4 TIMES OR DAY
Peachwood Place	North and West	Professor's Lake Parkway and the southerly limit	Anytime
Weather Vane Lane	North and West	Silo Court and Binder Twine Trail	Anytime

3. By-law 93-93, as amended, is hereby further amended by DELETING the following items from Schedule XV:

NO STOPPING

COLUMN 1 HIGHWAY	COLUMN 2 SIDE	COLUMN 3 BETWEEN	COLUMN 4 TIMES OR DAY
Devon Road	Both	A point 140 metres north of Intermodal Drive and Intermodal Drive	Anytime

4. By-law 93-93, as amended, is hereby further amended by ADDING the following items to Schedule XV:

NO STOPPING

COLUMN 1 HIGHWAY	COLUMN 2 SIDE	COLUMN 3 BETWEEN	COLUMN 4 TIMES OR DAY
Devon Road	West	A point 140 metres north of Intermodal Drive and Intermodal Drive	Anytime
Devon Road	East	Intermodal Drive and Clark Boulevard	Anytime
