(1) by changing on Schedule A thereto, the zoning designation of the lands as shown outlined on Schedule A to this by-law:



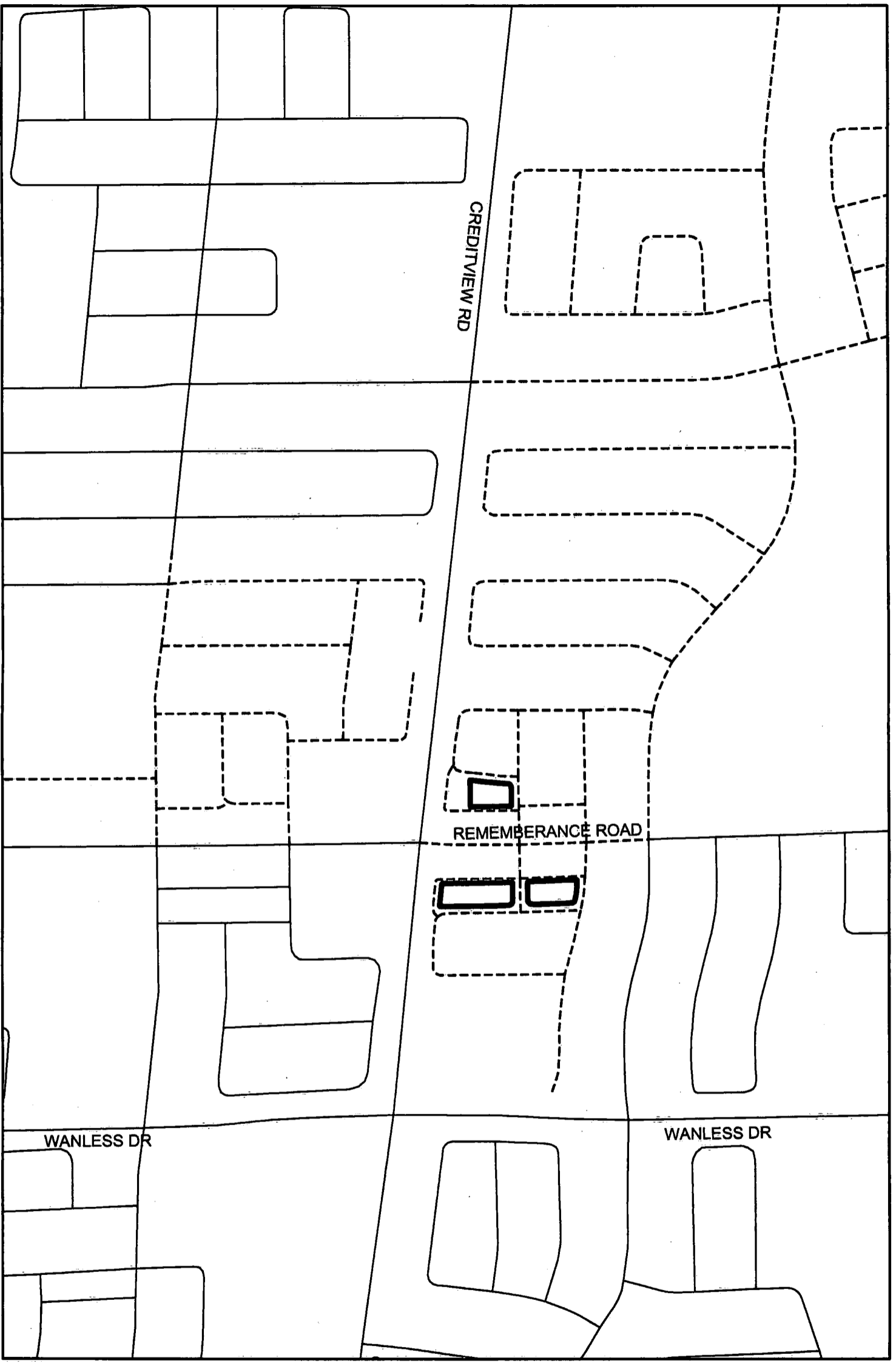

DECLARATION


I, Earl Evans, of the City of Brampton, in the Region of Peel, hereby make oath and say as follows:
