To approve the expropriation of certain lands for the widening of Countryside Drive from east of Goreway Drive to west of The Gore Road, Ward 10


**WHEREAS** the Council of the Corporation of the City of Brampton, at its meeting of July 8, 2015, enacted By-law 138-2015, to authorize an application for approval to expropriate certain lands and easements for the widening of Countryside Drive from east of the Goreway Drive to west of the Gore Road;

**AND WHEREAS** Notice of Application for Approval to Expropriate the said lands was served on all registered owners of those lands in accordance with the provisions of the Expropriations Act, R.S.O. c.E.26, as amended and no owners have requested an Inquiry under s. 6(2) of the said Act;

**NOW THEREFORE** the Council of The Corporation of the City of Brampton **ENACTS as follows:** 

- 1. The expropriation of the lands in the City of Brampton described in Schedule "A" to this By-law, for the purpose of the widening of Countryside Drive from east of the Goreway Drive to west of the Gore Road is hereby approved; and,
- 2. The Mayor and City Clerk, or their delegated authority, as the case may be, are hereby authorized to execute all documents, and the Mayor and the City Clerk are hereby authorized to execute, serve and publish on behalf of The Corporation of the City of Brampton, all notices, applications, advertisements and other documents required by the Expropriations Act, R.S.O. 1990, c.E.26 as amended, in order to complete the expropriation of the said property rights, based on terms and conditions acceptable to the Chief Planning and Infrastructure Services Officer, and in a form acceptable to the City Solicitor.
