To establish certain lands as  
part of the public highway system

(Cello Heights Court, Martin Byrne Drive, Cloncurry Street, Elderbridge Road, Galgate Way, Possession Crescent, John Carroll Drive and Countryside Drive)

WHEREAS it is deemed expedient to establish certain lands as part of the public highway system.


NOW THEREFORE the Council of The Corporation of the City of Brampton ENACTS as follows:


1. The lands acquired by The Corporation of the City of Brampton and described as Reserve Block 239 on Plan 43M-1959 is hereby established as part of the public highway system to be part of Cello Heights Court.
2. The lands acquired by The Corporation of the City of Brampton and described as Reserve Block 85 on Plan 43M-1981 is hereby established as part of the public highway system to be part of Martin Byrne Drive.
3. The lands acquired by The Corporation of the City of Brampton and described as Reserve Block 86 on Plan 43M-1981 is hereby established as part of the public highway system to be part of Cloncurry Street.
4. The lands acquired by The Corporation of the City of Brampton and described as Reserve Block 87 on Plan 43M-1981 is hereby established as part of the public highway system to be part of Elderbridge Road.
5. The lands acquired by The Corporation of the City of Brampton and described as Reserve Block 188 on Plan 43M-1998 is hereby established as part of the public highway system to be part of Galgate Way.
6. The lands acquired by The Corporation of the City of Brampton and described as Reserve Block 73 on Plan 43M-1992 is hereby established as part of the public highway system to be part of Possession Crescent.
7. The lands acquired by The Corporation of the City of Brampton and described as Part of Lot 16, Concession 9 Northern Division (Toronto Gore), designated as Parts 2 and 9 on Plan 43R-36345 are hereby established as part of the public highway system to be part of Possession Crescent.

8. The lands acquired by The Corporation of the City of Brampton and described as Part of Lot 16, Concession 9 Northern Division (Toronto Gore), designated as Parts 3, 4 and 8 on Plan 43R-36345 are hereby established as part of the public highway system to be part of John Carroll Drive.
9. The lands acquired by The Corporation of the City of Brampton and described as Part of Lot 16, Concession 9 Northern Division (Toronto Gore), designated as Parts 5, 7 and 13 on Plan 43R-36345 are hereby established as part of the public highway system to be part of Countryside Drive.
