# BY-LAW

Number 218 - 2016

To amend the Schedule of Traffic By-law 93-93, relating to DESIGNATED TURNING LANES (Schedule VI), U-TURNS (Schedule II), FIRE ROUTES (Schedule XXII), NO PARKING LOADING ZONE (Schedule XXXIII), NO STOPPING (Schedule XV) and RATE OF SPEED (Schedule X)

WHEREAS the Council for The Corporation of the City of Brampton has adopted the Traffic and Parking By-law No. 93-93, ("By-law 93-93") as amended to regulate the use of highways and parking in the City of Brampton;

AND WHEREAS pursuant to subsection 11 (3) 1 of the *Municipal Act, 2001* a by-law may be passed by a council of a municipality relating to the regulation of highways and parking within the municipality;

AND WHEREAS the Council of The Corporation of the City of Brampton is desirous of adopting a by-law to further amend By-law 93-93 by amending Schedule VI (DESIGNATED TURNING LANES), Schedule II (U-TURNS), Schedule XXII (FIRE ROUTES) and Schedule XXXIII (NO PARKING LOADING ZONES), Schedule XV (NO STOPPING) and Schedule X (RATE OF SPEED).

NOW THEREFORE the Council of The Corporation of the City of Brampton ENACTS AS FOLLOWS:

1. By-law 93-93 as amended, is hereby further amended by ADDING the following items to Schedule III:


