BY-LAW

Number 43 - 2017

To amend the Schedule of Traffic By-law 93-93, relating to THROUGH HIGHWAYS (Schedule III) and STOP SIGNS (Schedule IV)

WHEREAS the Council for The Corporation of the City of Brampton has adopted the Traffic and Parking By-law No. 93-93, ("By-law 93-93") as amended to regulate the use of highways and parking in the City of Brampton;

AND WHEREAS pursuant to subsection 11 (3) 1. of the *Municipal Act, 2001* a by-law may be passed by a council of a municipality relating to the regulation of highways and parking within the municipality;

AND WHEREAS the Council of The Corporation of the City of Brampton is desirous of adopting a by-law to further amend By-law 93-93 by amending THROUGH HIGHWAYS (Schedule III) and STOP SIGNS (Schedule IV);

NOW THEREFORE the Council of The Corporation of the City of Brampton ENACTS AS FOLLOWS:

1. By-law 93-93 as amended, is hereby further amended by ADDING the following items to Schedule III:

THROUGH HIGHWAYS

COLUMN 1 HIGHWAY	COLUMN 2 BETWEEN
Gardenbrooke Trail	The north limit of Penelope Street and the south limit of Bliss Street
Gardenbrooke Trail	The north limit of Bliss Street and the south limit of Academy Drive
Braydon Boulevard	The east limit of Whitwell Drive / Blaketon Court and the west limit of Merlin Drive / Pali Drive
Moira Creek Drive	The south limit of Countryside Drive and the north limit of Tomabrook Crescent / Abitibi Lake Drive
Moira Creek Drive	The south limit of Tomabrook Crescent / Abitibi Lake Drive and the north limit of Father Tobin Road

2. By-law 93-93 as amended, is hereby further amended by DELETING the following items to Schedule III:

THROUGH HIGHWAYS

COLUMN 1 HIGHWAY	COLUMN 2 BETWEEN
Gardenbrooke Trail	The north limit of Penelope Street and the south limit of Academy Drive
Braydon Boulevard	The east limit of Whitwell Drive / Blaketon Court and the west limit of Treeline Boulevard / Cosmo Court
Moira Creek Drive	The south limit of Countryside Drive and the north limit of Father Tobin Road

3. By-law 93-93 as amended, is hereby further amended by ADDING the following items to Schedule IV:

Braydon Boulevard at Merlin Drive/Pali Drive	Northbound on Pali Drive
Braydon Boulevard at Merlin Drive/Pali Drive	Southbound on Merlin Drive
Braydon Boulevard at Merlin Drive/Pali Drive	Westbound on Braydon Boulevard
Braydon Boulevard at Merlin Drive/Pali Drive	Eastbound on Braydon Boulevard
Moira Creek Drive and Abitibi Lake Drive / Tomabrook Crescent	Northbound on Moira Creek Drive
Moira Creek Drive and Abitibi Lake Drive / Tomabrook Crescent	Southbound on Moira Creek Drive
Moira Creek Drive and Abitibi Lake Drive / Tomabrook Crescent	Westbound on Abitibi Lake Drive
Moira Creek Drive and Abitibi Lake Drive / Tomabrook Crescent	Eastbound on Tomabrook Crescent
