# **BY-LAW**

Number \_\_\_\_ 105 \_\_\_ - 2017

To amend the Schedule of Traffic By-law 93-93, relating to NO PARKING (Schedule XIV) and NO STOPPING (Schedule XV)

WHEREAS the Council for The Corporation of the City of Brampton has adopted the Traffic and Parking By-law No. 93-93, ("By-law 93-93") as amended to regulate the use of highways and parking in the City of Brampton;

AND WHEREAS pursuant to subsection 11 (3) 1 of the *Municipal Act*, 2001 a by-law may be passed by a council of a municipality relating to the regulation of highways and parking within the municipality;

AND WHEREAS the Council of The Corporation of the City of Brampton is desirous of adopting a by-law to further amend By-law 93-93 by amending Schedule XIV (NO PARKING) and Schedule XV (NO STOPPING);

NOW THEREFORE the Council of The Corporation of the City of Brampton ENACTS AS FOLLOWS:

1. By-law 93-93, as amended, is hereby further amended by ADDING the following items from Schedule XIV:
