Number <u>115</u>-2017

To approve the expropriation of certain lands for the Goreway Drive Grade Separation between Steeles Avenue, Brampton and Brandon Gate Drive, Mississauga

WHEREAS the Council of The Corporation of the City of Brampton, at a meeting of January 25, 2017 enacted By-law 2-2017 to authorize an Application for Approval to Expropriate certain lands for the purpose of Goreway Drive Grade Separation Project between Steeles Avenue, Brampton and Brandon Gate Drive, Mississauga; and


AND WHEREAS Notice of Application for Approval to Expropriate the said lands was served on all registered owners of the lands and was published in accordance with the provisions of the *Expropriations Act*, R.S.O. c.E.26, as amended and no owners requested an Inquiry under s. 6(2) of the said *Act*;

NOW THEREFORE the Council of The Corporation of the City of Brampton HEREBY ENACTS as follows:

- THAT the expropriation of the property rights listed in the attached Appendix "A" for the purpose of the Goreway Drive Grade Separation Project between Steeles Avenue, Brampton and Brandon Gate Drive, Mississauga is hereby approved; and
- 2. THAT the Mayor and City Clerk, or their delegated authority, as the case may be, are hereby authorized to execute all agreements and other documents, and the Mayor and the City Clerk are hereby authorized to execute, serve and publish on behalf of The Corporation of the City of Brampton, all notices, applications, advertisements, agreements and other documents required by the *Expropriations Act*, R.S.O. 1990, c.E.26 as amended, in order to complete the expropriation of and settle the compensation for the said property rights based on terms and conditions acceptable to the Commissioner, Public Works and Engineering, and in a form acceptable to the City Solicitor or designate.
