# BY-LAW

Number 150 - 2017

**To amend the Schedule of Traffic By-law 93-93, relating to THROUGH HIGHWAYS (Schedule III), STOP SIGNS (Schedule XIV), and RATE OF SPEED (Schedule X)**

WHEREAS the Council for The Corporation of the City of Brampton has adopted the Traffic and Parking By-law No. 93-93, ("By-law 93-93") as amended to regulate the use of highways and parking in the City of Brampton;

AND WHEREAS pursuant to subsection 11 (3) 1 of the *Municipal Act, 2001* a by-law may be passed by a council of a municipality relating to the regulation of highways and parking within the municipality;

AND WHEREAS the Council of The Corporation of the City of Brampton is desirous of adopting a by-law to further amend By-law 93-93 by amending Schedule III (THROUGH HIGHWAYS, Schedule XIV (STOP SIGNS) and Schedule X (RATE OF SPEED);

NOW THEREFORE the Council of The Corporation of the City of Brampton ENACTS as follows:

1. By-law 93-93 as amended, is hereby further amended by DELETING the following items from Schedule III:

**THROUGH HIGHWAYS**

COLUMN 1 HIGHWAY	COLUMN 2 BETWEEN
Howard Stewart Road	The west limit of Little Britain Crescent (westerly intersection) and the west limit of Mississauga Road
Veterans Drive	The north limit of the roadway and the west limit of Creditview Road
Veterans Drive	The south limit of Sandalwood Parkway and the south limit of the roadway

2. By-law 93-93 as amended, is hereby further amended by ADDING the following items to Schedule III:

**THROUGH HIGHWAYS**

COLUMN 1 HIGHWAY	COLUMN 2 BETWEEN
---------------------	---------------------

Howard Stewart Road	The west limit of Little Britain Crescent (westerly intersection) and the west limit of Isle Royal Terrace
Howard Stewart Road	The east limit of Isle Royal Terrace and the west limit of Mississauga Road
Veterans Drive	The north limit of the roadway and the north limit of Yardmaster Drive
Veterans Drive	The south limit of Yardmaster Drive and the west limit of Creditview Road

3. By-law 93-93 as amended, is hereby further amended by ADDING the following items to Schedule IV:

**STOP SIGNS**

COLUMN 1 INTERSECTION or LOCATION	COLUMN 2 FACING TRAFFIC
Howard Stewart Road and Isle Royal Terrace	Westbound on Howard Stewart Road
Howard Stewart Road and Isle Royal Terrace	Northbound on Isle Royal Terrace
Howard Stewart Road and Isle Royal Terrace	Eastbound on Howard Stewart Road
Veterans Drive and Yardmaster Drive	Southbound on Veterans Drive
Veterans Drive and Yardmaster Drive	Northbound on Veterans Drive
Veterans Drive and Yardmaster Drive	Eastbound on Yardmaster Drive

4. By-law 93-93 as amended, is hereby further amended by ADDING the following items to Schedule X:

**RATE OF SPEED**

Howard Stewart Road	40	A point 13 metres west of Little Britain Crescent (westerly intersection) and Montpelier Street/Rising Hill Ridge	Anytime
Veterans Drive	40	Sandalwood Parkway West and Yardmaster Drive	Anytime
