# BY-LAW

Number 158 - 2017

To amend Interim Control By-law 306-2003, an Interim Control By-law applicable to Part of the Area Subject to By-law 270-2004, as amended, located at the north-east corner of the CN Railway Lands, approximately 350 metres south of Wanless Drive and east of Winston Churchill Boulevard, Part of Lot 15, Concession 6, W.H.S.

The Council of The Corporation of the City of Brampton, in accordance with the provisions of the *Planning Act*, R.S.O. 1990, c.P. 13, hereby ENACTS as follows:

1. By-law 306-2003 as amended, is hereby further amended as follows:

(1) Section 1 is amended by adding after the words "Section 1.20":

"and Section 1.22,"

(2) The following is added as Section 1.22:

1.22 The lands municipally known as north-east corner of the CN Railway Lands, approximately 350 metres south of Wanless Drive and east of Winston Churchill Boulevard, in Part of Lot 15, Concession 6, W.H.S. and referenced as the "Lands subject to specific exemption from Interim Control By-law 306-2003", as amended by By-law 158 as outlined on Schedule A to this By-law for the purpose of erecting a Billboard sign.

(3) Schedule A is deleted and replaced with Schedule A attached to this by-law.

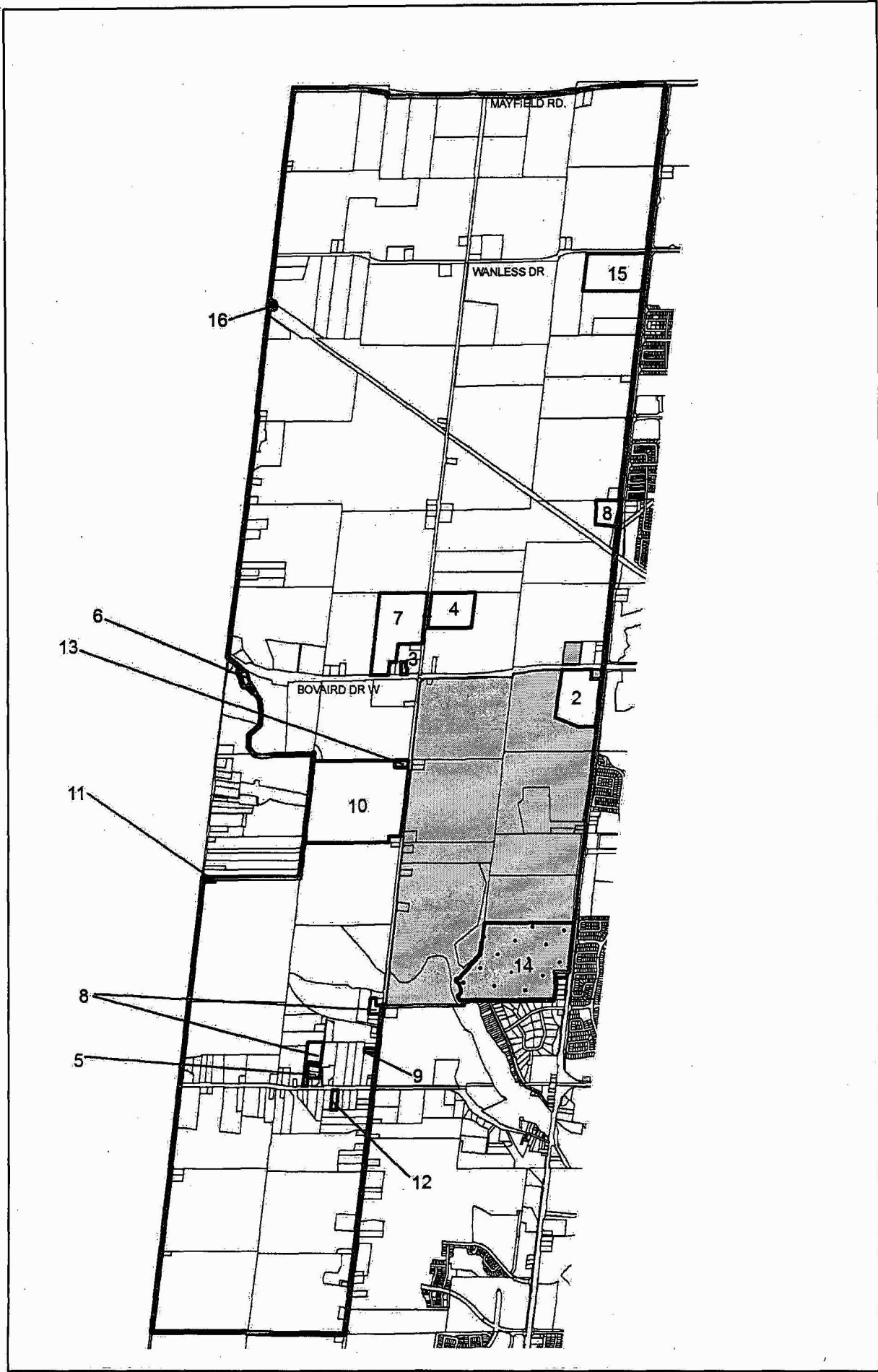
