BY-LAW

Number __ 175 _ - 2017

To amend the Schedule of Traffic By-law 93-93, relating to THROUGH HIGHWAYS (Schedule III) and STOP SIGNS (Schedule IV)

WHEREAS the Council for The Corporation of the City of Brampton has adopted the Traffic and Parking By-law No. 93-93, ("By-law 93-93") as amended to regulate the use of highways and parking in the City of Brampton;

AND WHEREAS pursuant to subsection 11 (3) 1 of the *Municipal Act*, 2001 a by-law may be passed by a council of a municipality relating to the regulation of highways and parking within the municipality;

AND WHEREAS the Council of The Corporation of the City of Brampton is desirous of adopting a by-law to further amend By-law 93-93 by amending THROUGH HIGHWAYS (Schedule III) and STOP SIGNS (Schedule IV);

NOW THEREFORE the Council of The Corporation of the City of Brampton ENACTS as follows:

1. By-law 93-93 as amended, is hereby further amended by ADDING the following items to Schedule III:

THROUGH HIGHWAYS

COLUMN 1 HIGHWAY	BETWEEN	
 Father Tobin Road	The east limit of Niceview Drive/ Sherbrooke Street and the west limit of Sunny Meadow Boulevard	-
Father Tobin Road	The east limit of Fairservice Drive and the west limit of Niceview Drive/ Sherbrooke Street	

2. By-law 93-93 as amended, is hereby further amended by DELETING the following items from Schedule III:

THROUGH HIGHWAYS

COLUMN 1 HIGHWAY	COLUMN 2 BETWEEN	
Father Tobin Road	The east limit of Fairservice Drive and the west limit of Sunny	

3. By-law 93-93 as amended, is hereby further amended by ADDING the following items to Schedule IV:

STOP SIGNS

Father Tobin Road and Niceview Drive/ Sherbrooke Street	Northbound on Niceview Drive
Father Tobin Road and Niceview Drive/ Sherbrooke Street	Southbound on Sherbrooke Street
Father Tobin Road and Niceview Drive/ Sherbrooke Street	Eastbound on Father Tobin Road
Father Tobin Road and Niceview Drive/ Sherbrooke Street	Westbound on Father Tobin Road
