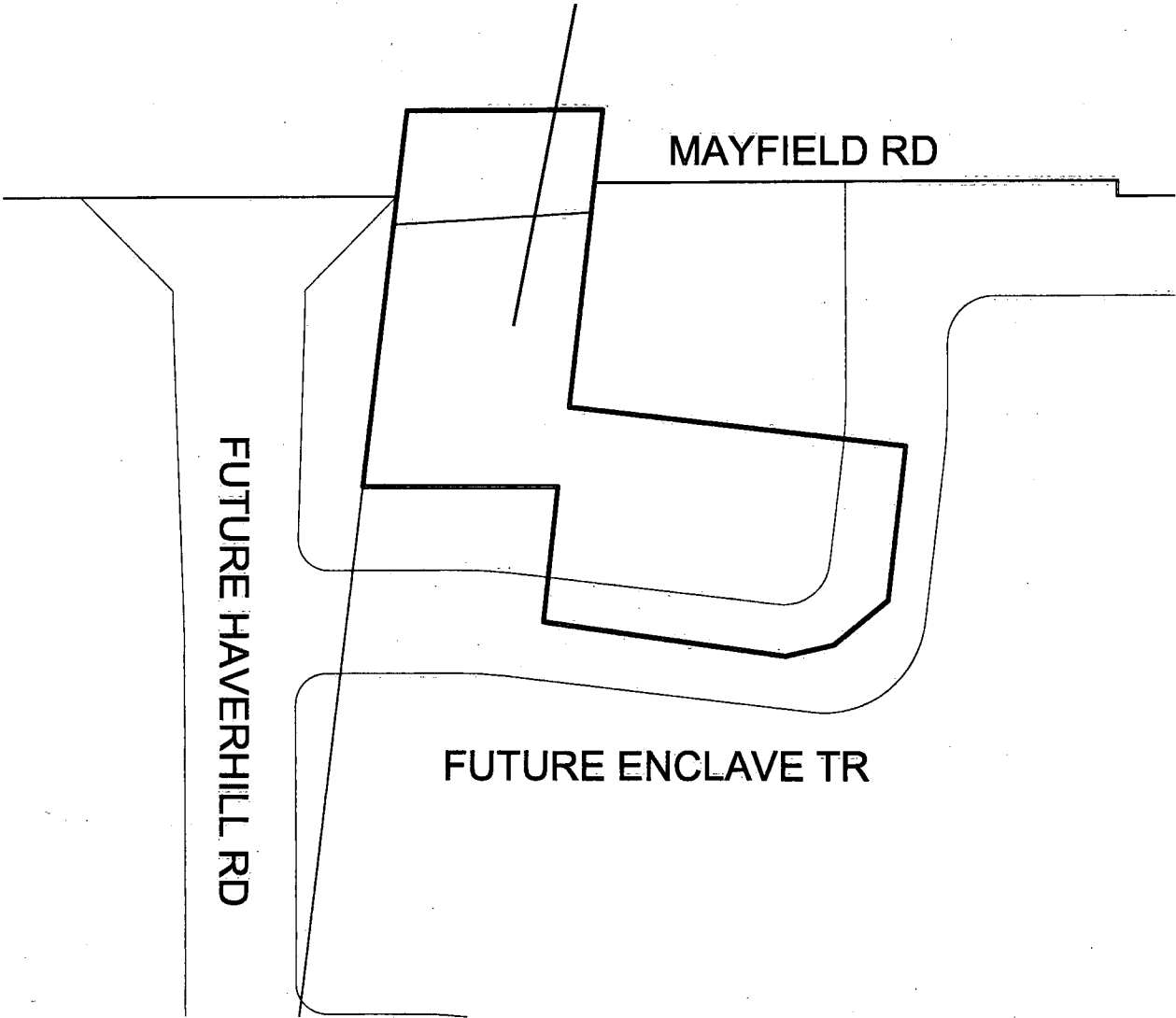

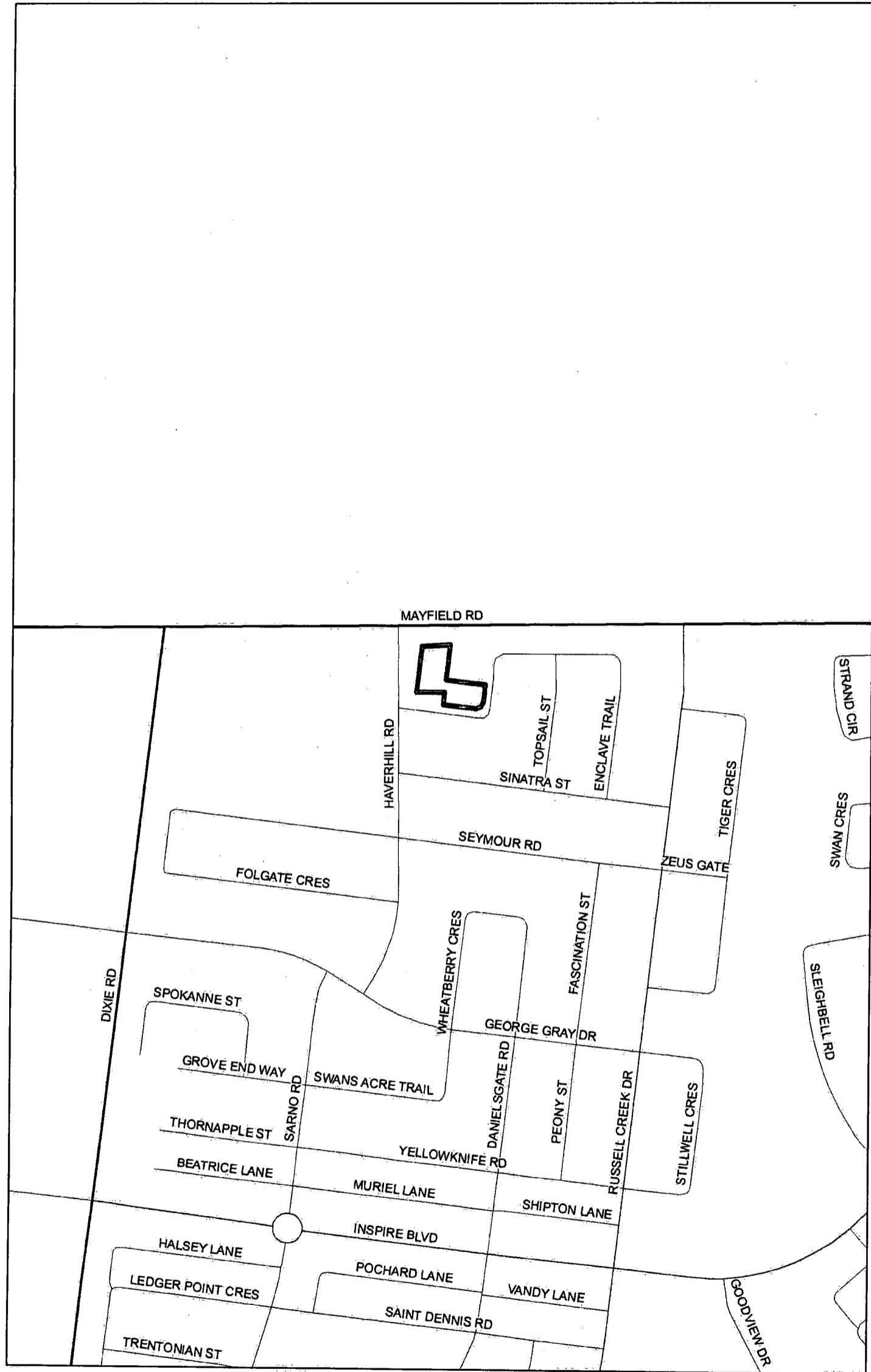


DECLARATION
