# Amendment to Business Licensing By-law 332-2013, as amended, to increase fees for Business Licences

WHEREAS Business Licensing By-law 332-2013, as amended was passed pursuant to the *Municipal Act, 2001*, respecting the issuance of Business Licences in the City of Brampton;

AND WHEREAS Appendix A to the Business Licensing By-law 332-2013, as amended, establishes fees for licences;

Pursuant to Resolution  $\underline{C353}$  - 2017, approved by City Council on November 22, 2017, it is deemed appropriate to amend fees for Business Licences;

NOW THEREFORE the Council of The Corporation of the City of Brampton ENACTS as follows:

1. That Business Licensing By-law 332–2013, as amended, is further amended by deleting Appendix A, Fee Schedule, and substituting therefore Schedule A attached hereto, effective as of the 2018 Licensing Period.
